This property is in census tract 8102, the City's south Neighborhood Revitalization Strategy Area and NSP2 target area. Ward Eight is an owner-operated neighborhood eatery that offers a seasonal menu, classic cocktails, craft beer, and boutique wines in a comfortable, friendly environment. Ward Eight will attract diners from the surrounding neighborhood and ultimately patrons of a theatre being planned in the next block of Howard Street in a second building acquired by the City with TIF funds.
