Quarterly Activities/ Project In Q4 2011, the City amended **Description** its CDBG-R plan following the requirements of its Citizen Participation Plan; the

amendment was approved by City Council at its meeting on November 14, 2011 and by HUD on November 23, 2011. The amendment allocates remaining CDBG-R funds

totaling \$131,453 for economic development in south Evanston, focusing on the

City's South Neighborhood Revitalization Strategy Area (NRSA) on Howard Street. This addresses the current priority of

expanding economic

opportunity by providing jobs and needed goods and services in this area. Assisting income eligible persons to establish micro-enterprises that

hire unemployed or under employed persons from the NRSA is one of the strategies being pursued. This replaces

the Howard Street

Improvement project, one of the two activities originally proposed for CDBG-R; the other activity, the Fleetwood Foster Improvement Project, is complete. No CDBG-R funded work was undertaken in Q4 2011. The City anticipates

approval of a specific economic development project or projects in Q1 2012.
