Metropolitan Planning Council Hosts Transportation Week Forum

On Wednesday, transportation stakeholders from across the region gathered at the Union League Club of Chicago to participate in a forum entitled "Infrastructure Week 2015: Broke, Broken and Out of Time". Homes for a Changing Region Toolkit Presentation

Pre-Application Deadline Approaching for MWRD Voluntary Flood-Prone Property Acquisition Program

The deadline to submit pre-applications for the Metropolitan Water Reclamation District (MWRD) Flood-Prone Property Acquisition Program is Friday, May 22. There are two avenues municipalities can utilize to participate in MWRD's program:

1. Local Sponsor Assistance Program: MWRD's top priority will be to facilitate the Illinois Emergency Management Agency's (IEMA) federally funded program by assisting Local Sponsor communities in providing their share of the cost for property acquisition.

2. Local Government Application Program: MWRD will consider applications directly from local governments requesting property acquisition of specific flood-prone structures.

A primary goal of this process is to enable communities to submit potential acquisitions without requiring a tremendous allocation of resources on their part. This will allow MWRD to prioritize the submittals and then invite the eligible local governments to submit a formal application and supporting documentation for further review and consideration. If ultimately selected, the local government will be responsible for managing the process to purchase parcels, acceptance of ownership, removal of existing structures, restriction of future development, maintenance and reporting.
