The Electric Franchise Agreement with ComEd is due to expire on September 12, 2015. The Utilities Commission considered what action to take with the Franchise, and as indicated in the attached memo, is recommending that the Franchise Agreement be extended an additional five years.

Based on this information, the Utilities Department will request the Legal Department to craft an Ordinance for the Franchise extension. The proposed Ordinance will be introduced at the July 27, 2015 and, if accepted, adopted at the August 17, 2015 Council meeting.

Recommended Action:

The Utilities Commission recommends that the City Council authorize a five year extension of the current Electric Franchise Agreement with ComEd.

Funding Source:

N/A

Background:

The City Council adopted Ordinance 58-O-10 that provided for a five year extension of the 1957 Electric Franchise Agreement between the City of Evanston and ComEd. This agreement will terminate on September 12, 2015. Section 3 of the Ordinance allows the City to re-extend the agreement an additional five years to September 12, 2020, at the City's sole discretion.

Summary:

The service provided by ComEd has greatly improved since the 1990s when the City initially refused to sign the standard franchise agreement with ComEd and began extending the 1957 Electric Franchise Agreement by three year terms. In 2010 the franchise agreement was extended for five years. During this five year period there were three major storms in 2011 that impacted the availability of electric service for most Evanston residents, some for several days. Barring the outage experienced during these storms, the reliability of ComEd service has shown steady improvement and ComEd continues to make improvements resulting in reducing both the frequency and duration of power outages in Evanston. During 2014, ComEd customers in Evanston experienced a 99.99% reliability rate.

As part of the Energy Infrastructure Modernization Act (EIMA), ComEd has installed several distribution automation devices in Evanston. These devices are designed to reduce the number of customers affected during an interruption by automatically isolating the disturbance on the circuit and providing power to the rest of the customers from other circuits. ComEd has also replaced thousands of feet of underground cable

within the past three years. Underground equipment failures had been the largest cause of interruptions in 2010, but have since dropped to an infrequent cause in 2014.

ComEd continues to comply with the projects and programs listed on Exhibit A attached to Ordinance 58-O-10 and the Utilities Commission Technical Review Group (TRG) continues to meet with ComEd semiannually to monitor compliance.

Based on the continued improvement demonstrated by ComEd, the Utilities Commission believes that extending the franchise agreement an additional five years is in the best interest of the City.

Temporary Holding Pattern in Place as Budget Stalemate Continues

The Governor and General Assembly are nowhere near reaching a meaningful compromise on the state budget that is supposed to go into effect on July 1. Governor Rauner wants five items from his "turnaround agenda" adopted prior to reaching a budget settlement: property tax freeze; term limits; worker's compensation reform; tort reform; and, redistricting reform. One of those five items, the property tax freeze, was under consideration when the General Assembly met on Tuesday.

The House Revenue and Finance Committee adopted the amendments to House Bill 690 and House Bill 691 and sent them to the House floor. On the floor, the House adopted the amendment to House Bill 690 (43-18-34) which would have provided a property tax freeze beginning in levy year 2015. However, the underlying bill only received 41 of the 71 votes required to override home rule authority. Amendment 1 to House Bill 691, which would have provided a property tax freeze beginning in levy year 2016, passed (44-21-33). A second amendment that contained the Governor's proposed changes to local prevailing wage and collective bargaining failed 0-69-26. Ultimately, House Bill 691 was not called for a final vote.

The Senate held a lengthy Committee of the Whole hearing with testimony from tax experts, schools, municipalities and other local governments. Metropolitan Mayors Caucus Executive Director Dave Bennett provided testimony regarding the effect of a property tax freeze on municipalities (you can view his testimony here beginning at 1:05:00 - Part 2). However, the Senate did not consider any specific legislation.

Both chambers will continue to meet every Tuesday through at least the end of June. It is likely they will continue the exercise of bringing up portions of the "turnaround agenda" up for consideration during those session days. It does not appear they will be taking up legislation outside of this context.

We will continue to monitor the activities in Springfield and forward information and action alerts to NWMC members as needed. When this process reaches a conclusion, we will likely highlight the final details via a NWMC Legislative Update. *Staff contacts: Mark Fowler, Larry Bury, Chris Staron*

MMC Housing Committee Discusses Code Enforcement Options

On Tuesday, the Metropolitan Mayors Caucus Housing and Community Development Committee met to discuss new code enforcement options. Staff discussed a new report generated for the South Suburban Mayors and Managers Association by the Center for Community Progress that describes ways to incentivize responsible landlord behavior. The report presented case studies from both home rule and non-home rule communities. Staff from the Metropolitan Planning Council discussed their Up To Code program, which aims to help municipalities in southern Cook County dealing with issues of foreclosure, vacancy and property maintenance. Representatives from the Ancel Glick law firm discussed a new pilot project to increase code enforcement capacity in smaller municipalities. What is being termed the "Administrative Hub" will provide outsourced administrative support for municipal code enforcement. The program, currently in its third week of operation, involves four suburban communities and streamlines the enforcement of liens and allows municipal building inspectors to have more time in the field.
