NWMC Board Approves Legislative Accountability Plan, Route 53/120 Letter of Support

Thank you to the twenty-eight members who attended Wednesday night's NWMC Board meeting. The membership unanimously approved a district-centric legislative strategy with the goal of strengthening the organization's legislative outreach and effectiveness. Staff will begin to work with the membership to implement the strategy and enhance legislative mobilization efforts. The board also approved amendments to the NWMC financial and investment policies as well as changes to the organization's banking and investment services as recommended by the Finance Committee.

In other board action, the membership approved a letter reaffirming the organization's support for the proposed Illinois Route 53 Extension and the Route 120 Bypass in Lake County. The letter was sent to Illinois Tollway Board Chairman Bob Schillerstrom in anticipation of the Tollway's consideration of an Environmental Impact Statement on the project. Finally, staff reported on an agreement between the Chicago Metropolitan Agency for Planning (CMAP), the Illinois Department of Transportation (IDOT) and the Federal Highway Administration (FHWA) to restore federal funding to CMAP and keep their offices open. Until a state budget is passed, FHWA will make direct payments to CMAP so that the organization can maintain its current operations, while IDOT will retain their regular oversight responsibilities. *Staff contacts: Mark Fowler, Larry Bury*

SPC Grants Final Ambulance Contract Extension – Order Before Prices Go Up

The Suburban Purchasing Cooperative (SPC) Governing Board has awarded the final contract extension on the 2016 Horton Type I Additional Duty Ambulance (Contract #133) to Foster Coach Sales, Inc., of Sterling. The contract runs from January 21, 2016 through October 1, 2017 and contains a 3.5% price increase.

Horton Emergency Vehicles has introduced a new Intelliplex i4G system and new door handles for 2016, which are partly responsible for the price increase. Additionally, 2016 federal and state specifications require a 4-point harness for seating areas in the patient compartment, making it safer for the attendant in the back of the ambulance. MMC to Update Greenest Region Compact

The Metropolitan Mayors Caucus (MMC) Environmental Committee is working to update the Greenest Region Compact (GRC), which was originally introduced in 2007. The committee is reviewing the original GRC, taking an inventory of all environmental achievements by municipalities in the region, and analyzing all regional and national sustainability plans.

The committee has produced a framework of goals for the new plan based on ten categories: land use; waste and wastewater; waste and recycling; sustainable communities; energy; economic development; mobility; municipal operations; climate change; and, leadership. Additionally, the new Greenest Region Compact will include best practices and lists of resources for use by individual or groups of municipalities.
