Transportation Committee Talks CMAP Funding, Regional Bike Planning

The NWMC Transportation Committee met Thursday and discussed proposals from the Chicago Metropolitan Agency for Planning (CMAP) to secure more consistent local matching funds for the federal planning funds they receive. The options include lobbying the General Assembly to fully fund the Comprehensive Regional Planning Fund (CRPF), imposing dues on local transportation agencies and municipalities as well as implementing fees for some of CMAP's services and programs. Legislation has been introduced in Springfield (HB 6286 and SB 2966) to fund the CRPF while a decision on the dues and fees is expected to be approved at CMAP's March 9 Board meeting.

The committee also discussed an effort led by the Lake County Division of Transportation, the Cook County Department of Transportation and Highways and the *Village of Northbrook* to design and build a bridge over Lake-Cook Road to connect the existing Skokie Valley Trail in Lake County to a planned extension of the trail to the south. Finally, the committee was briefed on the Active Transportation Alliance's Chicagoland Complete Streets Coalition, which is co-chaired by NWMC staff. The coalition aims to serve as a regional forum to advance the implementation of complete streets. *Staff contacts: Mike Walczak, Brian Pigeon*
