Transportation Committee Hears 2018 Agency Budget Woes

The impact of state imposed cuts across transportation agencies was the common theme of Thursday's NWMC Transportation Committee meeting as representatives from Metra, Pace and IDOT outlined the impacts on their 2018 budgets. Metra Community Affairs Director Rick Mack discussed the fare hikes and service cuts proposed in the agency's 2018 budget. These include fewer trains on the Milwaukee North and North Central Service lines as well as a variety of fare increases proposed to help fill a \$45 million gap. Metra Board Chair Norm Carlson, Secretary Rod Craig and incoming Executive Director James Derwinski will provide additional details at the November 8 NWMC Board meeting.

Pace Community Relations Representative Steve Andrews described proposed increases on cash and Ventra fares to balance his agency's budget and said that no Pace service cuts are planned for 2018. Finally, IDOT Area Programmer Tavis Farmer discussed more than a dozen local projects which are being delayed due to a \$300 million statewide cut to IDOT's 2018 Highway Improvement Program. The delayed projects in the NWMC area will be pushed back one or more lettings due to this lack of state funding. The next NWMC Transportation Committee meeting is scheduled for Thursday, November 30 at 8:30 a.m. at NWMC offices and will feature an update from the Illinois Tollway on its local projects and a presentation on the RTA's Regional Transit Strategic Plan. *Staff contacts: Mike Walczak, Brian Pigeon*
