## City of Evanston Special One-Day (Class Z¹) Liquor License Application (Beer & Wine / Non-City Premises)

Attached is the *City of Evanston Special One-Day (Class Z¹) Liquor License Application*. Please complete, sign, and submit the application to the City Liquor Licensing Department, including all necessary attachments <u>at least 30 days prior to the date of the event</u>. The following items must be attached to your completed application when it is submitted. Any missing information may delay the process.

- 1. A Certificate of Liquor Liability Insurance (Dram Shop), naming the "City of Evanston" as an Certificate Holder in the amount of one million dollars (\$1,000,000.00) for the period of time during which liquor will be served and sold.
- 2. A written Statement of Consent from the owner of the premises where liquor will be sold (should the applicant not be the property owner).
- 3. If alcoholic liquor service is provided by a caterer, a copy of the executed catering contract.
- 4. A check made payable to the "City of Evanston" in the amount of one hundred fifty dollars (\$150.00).
- 5. Proof of BASSET training by either the <u>owner/manager/staff</u> of the establishment where the event will occur or <u>representative of the entity sponsoring the event</u>. Training must have occurred within the past three (3) years and the person must be on site for the duration of the event.

## Special One-Day (Class $Z^1$ ) Liquor Licenses are subject to the following conditions:

- The class Z<sup>1</sup> license shall authorize the consumption of beer and wine only.
- Only Evanston entities may receive a Special One-Day Liquor License. Evanston entities are defined to include individuals residing within the City; businesses with a permanent address located within the City; and educational, fraternal, political, civic, religious or not-for-profit organizations located within the City.
- ♦ The <u>sale</u> of beer and wine shall only take place from 10:00 a.m. to 10:30 p.m. Sunday through Thursday, and from 10:00 a.m. to 2:00 a.m. Friday and Saturday.
- ♦ This license is for the <u>sale of liquor</u>. Fundraisers, tickets sales and donations all qualify as "sale" of alcohol if said transactions are expected in return for alcohol service. Gratuitous (free) service of liquor to invited quests on your private property is not regulated by the city and does not require a license.
- It is highly recommended that food be provided and made available during the hours of sales and service of liquor.
- The license shall be issued to and valid only for the "sales premises" described on the application.
- ♦ No more than twelve (12) Special One-Day Liquor Licenses shall be issued to any one sales address or applicant in any one calendar year.
- ♦ No person under twenty-one (21) years of age may purchase or consume any form of alcoholic liquor at a licensed event.

All applications for Special One-Day (Class  $Z^1$ ) Liquor Licenses shall be submitted to the Liquor Control Commissioner, who shall have the authority to grant or refuse all Special One-Day Liquor Licenses.
