





CMAP Board and MPO Policy Committee Approve Recommended Transportation Programs

On October 11, the Chicago Metropolitan Agency for Planning (CMAP) Board and Metropolitan Planning Organization (MPO) Policy Committee met jointly and approved the <u>FY 2020-2024 Surface Transportation Program</u> (<u>STP) Shared Fund</u> as recommended by CMAP staff. The recommended program includes two projects from the Northwest Council of Mayors: the U.S. Route 14 grade separation project in the *Village of Barrington*; and, an intersection improvement project on Irving Park Road at Bartlett Road in the *Village of Streamwood*. More than \$50 million in federal funding is programmed between the two projects.

The CMAP Board and MPO Policy Committee also voted to approve the recommended programs for both the <u>Congestion Mitigation Air Quality (CMAQ) and Transportation Alternatives Program (TAP-L)</u>.
