City of Evanston 2020 MFT Street Resurfacing Project

June 8, 2020

Project Description

Over the next twelve weeks, the City of Evanston will be contracting road resurfacing work on thirteen street segments throughout the City. This project involves curb replacement as needed, roadway base repair, sewer work, replacement of asphalt surface from curb to curb along with selected ADA sidewalk replacement and driveway aprons. The funding for the project will be from the City’s Rebuild Illinois and Motor Fuel Tax (MFT) Funds and there will be no direct charge for the property owners on these streets. The construction has been planned in two phases and the specific locations included in each phase of construction are listed below.

Construction will begin **the week of June 15** on several street segments with the entire project expected to be fully completed by the end of **September**. The actual date when construction is planned for your street will be noted on the temporary **NO PARKING** signs posted 48 hours prior to the start of work. The construction activities will create some inconvenience for abutting residents, but we will attempt to minimize these inconveniences. Construction zone daytime **NO PARKING** restrictions will be intermittent throughout the duration of the project; evening and nighttime parking (5:00pm to 7:00am) will always be available. Street sweeping and/or neighborhood parking restrictions will be waived for a one block radius around the construction zone when temporary daytime **NO PARKING** is in effect.

Contractor

The contractor for this street improvement project is J.A. Johnson Paving, 1025 E. Addison Court, Arlington Heights, IL 60005.

City Supervision

The project is under the supervision of the City’s **Capital Planning & Engineering Bureau**. The Resident Engineer in the field will be Pankaj Chokshi who will be directly responsible for all aspects of the construction.
