# Mayor's Task Force Briefing Meeting Notes

# Friday, September 18, 2020

# What's On My Mind (Mayor Hagerty)

- Mayor Hagerty noted that while the City's response to the pandemic is of critical importance there are other areas of importance such as racial justice and climate change. These areas should have a response similar to the pandemic
- Region 10 COVID-19 numbers are a lot better than they have been. Evanston has seen an
  increase in the number of cases but the positivity rate remains around 1.67%
- The community needs to do more to save the business community

# **Brief Prior Day's Situation Report**

- Still in phase 4: Revitalization
- EMS Region 10 positivity rate dropped to 5%
- Hospital capacity remains the same
- o The infection rate continues to decrease. As of Thursday, the infection rate was around .9%
- The state's infection rate is at .96%
- The state has less than 270,000 cases, Suburban Cook County around 60,000 cases,
   Chicago around 76,000 cases, and Evanston has around 1,075 cases
- Evanston averaged 7 cases over the last 7 days.
- Evanston's positivity rate is around 1.67%
- Evanston is at 145 cases per 10,000, Skokie is at 223 cases per 10,000 and Chicago is at 282 cases per 10,000
- Evanston's fatality rate has decreased to less than 7%
- Long-term Care Facilities continue to do well overall. There was one 1 staff and 2 resident cases at Albany Care.

# **Sector Updates**

### Hospitals

St. Francis Hospital

- o 7 confirmed cases, 2 patients in ICU, and 1 patient on a ventilator.
- No deaths in 24 hours. Continuing to use social media to advertise safe hospital and to welcome visitors

## North Shore Hospital

- o 10 patients at Glenbrook, 8 patients in ICU, and 1 PUI at Evanston Hospital
- At a 6.2% positivity rate
- 10.8% serology rate

#### **Senior Living Center**

 Congregate housing providers have been doing well. CMS came out with new guidelines for visitors. Evanston providers would be working to implement the new guidelines

#### **PNPs**

 Making sure District 65 students who need supervision are provided with a brick and mortar space. Continue to seek out free, low-cost testing for Early Childhood teachers

#### **Northwestern University**

Students are back. Still in Wild Cat Wellness period. University conducted over 10,000 tests in 3 weeks on-site. Positivity rate about .4% overall. For Undergraduates, the positivity rate is around .5%. Starting on Monday, undergraduates would go through weekly testing. In-person classes would start on Monday. #### **Schools District 65**

- Working to design a camp for student populations who don't have resources or homes not conducive to learning. Partnering with YMCA and Y.O.U. Camps will serve over 340 students
- Continuing to monitor the positivity rate. The goal is to launch in-person learning on November 16.

#### District 202

 Doing a good job identifying students who need additional support. Repurposed number of employees to support students.

# **Schakowsky**

- Democrats Weigh Next Stimulus Steps: Some House Democrats are keeping pressure on Speaker Nancy Pelosi (D-Calif.) to bring a new pandemic relief bill for a vote next week, as they look to signal to voters that their party is pursuing an agreement to bolster the U.S. economy. Pelosi said yesterday that voting on some version of a Democratic stimulus bill is one of the options that's been under discussion within the party to break the impasse with their Senate Republican counterparts and the White House.
- Some Democrats want to vote again on the \$3.4 trillion stimulus package the House passed in May, she said at a news conference, while some lawmakers don't want to advance any legislation until they strike an agreement with the Trump administration
