3. Approval of the December 5, 2019 Meeting Minutes

December 5, 2019 meeting minutes were approved

4. Update on UNC Study

a. Traffic Study

- 2017 a traffic study came to City Council with statistics on where we are now with traffic stops of black male juveniles.
- A timeline on when the information will be completed will take place on the next Alternative to Arrest meeting.
- (Side Note) Marijuana has to be purchased at the dispensary, if stopped with marijuana in vehicle without it in the proper concealer; one will receive a traffic ticket-violation.

5. Juvenile Hearings Update:

- There have been 34 cases; of the 34 cases 16 of them have completed community service. Only 3 cases were fined for not appearing for community service.

- If any juvenile miss up to three hearings, then the adjudicator will refer them to EPD. The referral will come from the adjudicator to the EPD to send the case/juvenile out to Skokie.
- After the 3rd failure, Renee will forward to Charlotte and Commander Brian Henry for court referral to include adjudicator recommendations.
- One person pled not guilty.
- Recommendations on Juveniles who do not appear to court, what are the repercussions?

6. Misdemeanor Offenses for Consideration:

- Battery Charges should be off the table for conversation due to discretion.
- Eliminate the practice of juveniles being held in the police department.
- What additional misdemeanors for juveniles need to be modified in the city code?
- Expunge for juveniles by the age of 18, all their tickets and violations will be erased. Look more into the offenses coming in against the juveniles, and gather data for juveniles and parents to educate on what happens to their offenses once they turn 18.
- Heather will be added to the meetings in the future.
