1. Called to order/Declaration of Quorum:

Chair Jane Grover called the meeting to order at 6:34 p.m. and declared a quorum.

2. Approval of the November 19, 2020 Meeting Minutes

Commissioner Delores Holmes moved to approve the November 19, 2020 meeting minutes; Vice Chair Alejandra Ibanez seconded. Minutes approved unanimously.

b. Draft Mission Statement

- Vice Chair Alejandra Ibanez led the discussion around the mission statement draft. The purpose of the mission statement is to describe the work of the Equity and Empowerment Commission, who we do the work for and the benefits of the commission.
- Commission members gave feedback on the wording of the mission statement in order to establish the seriousness of structural racism within the community, as well as, in policies and how to create language to eliminate it.

 Vice Chair Alejandra Ibanez committed to apply the edits and feedback from the commission to an updated mission statement draft, and share during the next meeting.

- Commissioner Max Weinberg presented the timeline for the project, the questionnaire discussion for BCC liaisons, and the deliverable date for the next commission meeting.
