
Subject: 1005 Howard Street Development

Date: January 25, 2021

As part of the construction of the development at 1005 Howard Street, a subcontractor will be trucking precast building panels to the construction site beginning the first week of February. It is anticipated that 250 to 280 trips will be made over a three week period. The loaded trucks will turn onto east bound Howard Street from McCormick Blvd and continue to the construction site. There flagmen will be used to stop traffic and allow the truck to park along the north curb line where it will be unloaded. The unloaded trucks will then exit the construction site going east bound on Howard Street to Chicago Avenue, north on Chicago Avenue to Clark/Elgin Road and then west on Emerson Street to leave the City.

Subject: Political Activity Prohibited on City Property

Date: January 25, 2021

As this year's elections are approaching, please see the reminder/information for everyone regarding the use of City facilities for political activities.

The Evanston City Code 1-10-4(J) states, "*Public Property*. No covered person shall permit the use of or engage in the unauthorized use of City owned funds, vehicles, equipment, materials or property of any kind for political activity, personal convenience or profit or for any other matter not related to official City business. This prohibition shall apply irrespective of whether or not the public property is returned or reimbursed. This prohibition shall not apply to the use of non-powered traffic control items such as cones or other barricades used for civic events or block parties. **No political activity may take place on any City property or at any City Ward Meeting**." (emphasis added).

The <u>Civic Center</u> can only be used for candidate forums, NOT political activities related to an election. Rules for forums at the Civic Center are:

- 1. All candidates must have been invited to attend;
- 2. The forum is sponsored by a non-partisan group; and
- 3. All candidates for office must agree in writing to attend or indicate they do not oppose the forum being held\*\*.

Due to the COVID-19 Pandemic, the Civic Center is closed to the general public at this time. Other municipal buildings and the Library must also follow the three rules above for forums.

\*\*Under City Rules, if a candidate cannot attend and opposes the forum being held, it cannot be held on City property.

### NWMC Here to Help Update

On Monday, the state officially moved to Phase 1b of the <u>COVID-19 vaccination plan</u>. 3.2 million Illinoisans are eligible to receive the vaccine in Phase 1b, including 1.3 million <u>"Frontline Essential Workers"</u> and 1.9 million residents age 65 and older. Over 800,000 individuals were added to Phase 1b when the state lowered the eligible age to receive the vaccine from 75 to 65. Governor Pritzker also announced a new portal on the state's <u>Coronavirus</u> (<u>COVID-19</u>) <u>Response</u> website which lists vaccine locations, eligibility/appointment information and vaccination status by county in addition to the list of testing sites.

Members have requested that the state consider expanding the list of frontline essential workers eligible under Phase 1b to include public works employees, inspectors and others who interact with the public, but the overarching issue continues to be the limited supply of the vaccine. During a meeting of the Metropolitan Mayors Caucus COVID-19 Task Force on Tuesday, it was noted that future adjustments could be made to the list, but that depends on access to additional vaccines. Additionally, for members who have been asking if local EMTs could be trained to administer the vaccine, we were told at the meeting that the decision rests with the local Emergency Medical System (EMS) Medical Directors. It was recommended that municipal officials wishing to offer their EMTs to perform this service should contact the EMS that serves your community.

Last Friday, staff sent to Cook County Commissioner Scott Britton the results of a survey of our Cook County members identifying possible mass vaccination sites as the county begins to ramp up its vaccination plan. Thank you to the eleven NWMC Cook County communities who responded to the survey. Finally, thank you to NWMC members who sent letters to our congressional delegation requesting their support for direct federal assistance to local governments to make up for tax revenues due to the ongoing pandemic. Staff received letters this week from *Glencoe* and *Highland Park* asking lawmakers to support President Biden's <u>American Rescue Plan</u>, which proposes "\$350 billion in emergency funding for state, local, and territorial governments to ensure that they are in a position to keep front line public workers on the job and paid, while also effectively distributing the vaccine, scaling testing, reopening schools, and maintaining other vital services." We encourage all members to contact their congressional members in support of funding for local governments.

### Transportation Committee Discusses RTA Mobility Outreach

The NWMC Transportation Committee met Thursday and received several updates from regional partners as well as a presentation from Regional Transportation Authority (RTA) Mobility Outreach Coordinator Sarah Blair. ### EPA Opens Diesel Emissions Reductions Act Grant Applications

The Environmental Protection Agency (EPA) anticipates awarding approximately \$46 million in competitive grant funding under the <u>Diesel Emissions Reductions Act (DERA) National Grants Program</u>. The program is soliciting applications nationwide for projects that achieve significant reductions in diesel emissions and exposure, particularly from fleets operating in areas designated by the EPA as having poor air quality.

Application packages must be submitted electronically to EPA through <u>Grants.gov</u> no later than 11:59 p.m. ET on Tuesday, March 16 to be considered for funding.
