3. Mission and Goals

a. Racial Equity Impact Framework

- Committee Member Alejandra Ibanez shared a racial equity framework/toolkit from GARE in explaining why this committee should use this racial equity toolkit.
- The toolkit is designed to help this committee to figure out how to go from the theoretical of what racial equity is to the actual implementation of racial equity work.
- There are six simple questions for the committee to review when discussing data and implementation strategies. Those questions are:
 - **1. Proposal:** What is the policy, program, practice or budget decision under consideration? What are the desired results and outcomes?
 - 2. Data: What's the data? What does the data tell us?
 - **3. Community engagement:** How have communities been engaged? Are there opportunities to expand engagement?

- **4. Analysis and strategies:** Who will benefit from or be burdened by your proposal? What are your strategies for advancing racial equity or mitigating unintended consequences?
- **5. Implementation:** What is your plan for implementation? Government Alliance on Race and Equity TOOLKIT Racial Equity Toolkit: An Opportunity to Operationalize Equity 7
- **6. Accountability and communication**: How will you ensure accountability, communicate, and evaluate results?

b. Shared Safety Framework

- Committee Member Evangeline Semark presented on a Shared Safety Framework that is used to build an approach to public safety that is rooted in true prevention, accountability and restoring the wellbeing of the community.
- The Blueprint of shared safety highlighted a year of research and outreach to help shift the focus of over incarceration to investments that will truly make communities safer.
- The five guiding principles for Shared Safety serve as the foundation for reimagining public safety here in Evanston. Those five principles are:
 - 1. Shifting to a Public Health Frame
 - 2. Well-Being is Safety
 - 3. Crime Survivors at the Center
 - 4. Breaking the Cycle of Harm
 - 5. Making the System Work

- Mayor Biss led the discussion around which six working group topics should this committee focus on as a start. Committee members were asked to choose which working group they would like to participate in and select which three topics will become the top priorities.
- The six working group topics are:
 - a. Traffic & pedestrian enforcement

 - c. Rethinking the organizational structure -- if we were building a police department from scratch, what would it be?
 - d. Violence prevention/violence interruption strategies
 - e. SROs
 - f. Use of Force Policies
