1. CALL TO ORDER / DECLARATION OF QUORUM

- a. Committee discussed having specific topics at the meetings to inform members on government financial practices. The following topics were proposed:
 - i. Municipal advisor from Speer Financial for January meeting: longer discussion on bonds in terms of what is issued every year, when does refinancing make sense, where are the judgement and qualitative decisions during the bond issuance process, funding of capital by bonds
 - ii. Police & Fire Pensions for February meeting How do these factor into the budgeting process
 - iii. Overview of Capital Planning process for March meeting
- b. Open meetings act Majority of a quorum is the most you can have 2 for this committee is the most you can have
 Wynne will talk with Corporation Counsel to work out details and figure out what is possible for subcommittees

Would have to take to Rules committee to confirm if we can have subcommittees of 3 and what would be required
