4. DISCUSSION

A. Nomination of the Chair and Vice-Chair

B. Evanston Community Equity Survey Update

Karla Thomas gave an update on the strategy for distributing the survey. The commission will plan to send the survey through normal channels such as a press release and aldermanic newsletters as well as be shared directly with organizations that can access populations who don't normally respond to surveys. There will be no set deadline for the survey, but once a thresh hold for representativeness is met across measured categories, the survey will be closed.

C. Development of an Equity Review Tool (Rubric)

Karla Thomas presented a draft of the scorecard. There is a primary general rubric and additional rubrics for policy issues that the Commission anticipates coming up often. The commission discusses who would use the rubric and when they would use it.

D. Environmental Equity Planning Investigation

Andy Schlickman reported the Environmental Justice Evanston status report and expressed interest in coordinating with the EEC. Andy will act as a liaison moving forward to ensure appropriate coordination. In February, the commission will have a more in-depth discussion with Environmental Justice Evanston.
