#### Transportation Committee Reviews New Infrastructure Opportunities

At Thursday's NWMC Transportation Committee meeting, staff presented an overview of the Infrastructure Investment and Jobs Act (IIJA), including Illinois-specific funding levels, recommendations for communities, a funding timeline and additional highlights. The bill provides \$248 billion for transportation investments and will be split into both new and existing formula programs as well as competitive programs.

Almost all formula programs available to Illinois and the north and northwest suburbs received an increase in funding. As further guidance is prepared, communities should start identifying projects compatible with the legislation's vision and reviewing project specific eligibilities and requirements.
