#### CALL TO ORDER/DECLARATION OF A QUORUM

The meeting was called to order at 9:01 a.m. by Chair Councilmember Braithwaite.

#### CONSIDERATION

#### Approval of the Restorative Housing "Ancestor" Category Recipient List

Committee member Robin Sue Simmons, Committee member Sutton, Committee Member Lockhart, Committee member Barber, and Councilmember Burns gave speeches acknowledging the reparations process thus far. Councilmember Braithwaite thanked those who contributed to the development of the Restorative Housing Reparations program. Councilmember Braithwaite explained there were over 600 applicants, and the Reparations Committee gave direction to prioritize the ancestor category of applicants. All names in the ancestor category would be drawn and placed in order. In total, 123 recipients applied as ancestors. The Committee randomly selected the ancestor applicants in the following order:

#### Summary:

Staff has begun meeting one-on-one with the selected first sixteen reparations beneficiaries regarding the Restorative Housing Program. Beneficiaries were provided an overview of the three program benefits (Home Purchase Benefit, Home Mortgage Assistance Benefits, and Home Improvement Benefit) and their respective procedures. Staff also inquired of beneficiaries' housing needs and recommended alternative programs/resources that could supplement the beneficiaries' Reparations benefit of \$25,000 where appropriate.

Thus far, staff has met with eight of the first sixteen reparations beneficiaries. **Table 1** below summarizes the wards the eight beneficiaries belong to and their selected benefit. **Table 2** and chart includes the Ward demographics of all 123 selected Ancestors.






Staff update regarding tax implications of reparations benefits

Committee Action: For Discussion

#### Summary:

From the start, the City's reparations programs have been designed to have little to no tax implication on recipients. Yet questions surrounding the implications persist. To that end, the law department retained Tax Law Offices, Inc., a Black owned tax firm to opine on the potential consequences of the City's current program; any program that may provide a direct cash payment; and finally, any implication on entitlement aid/benefits.

Tax Law Offices, Inc. has offices in Illinois, Maryland and South Carolina with accountants and lawyers who are former IRS employees on staff.



#### Summary:

As of March 1, 2022, the City has received **\$69,103** in donations to the Reparations Fund. This represents an increase of 41% from December 2021.

As to the 3% Cannabis Retailers' Occupation Tax on adult/recreational cannabis sales within the City, the Committee should note that per the state statute (35 ILCS 120/11), the City cannot share reasonable statistics concerning the operation of the 3% tax or share allocations received from this tax since there are fewer than 5 adult-use cannabis dispensaries in Evanston. Doing so would be a breach of confidentiality.
