Applicant accepts responsibility for the placement and removal of the barricades furnished by the Evanston Division of Streets and Sanitation and agrees to protect them from damage and vandalism. 5. Applicant accepts responsibility for the activities to be conducted throughout the term of this permit and agrees to clear the area of any refuse or debris which may result from the activities. 6. The City of Evanston's city code does not authorize the issuance of permits for loudspeakers and other related amplification equipment for block parties. Inflatable structures such as bounce houses cannot be placed in the street. 7.
