Cara: \$500,000 earmark from Federal government for Accessible Solar Program, part of FY22 Omnibus Appropriations

Climate emergency resolution

Reviewed revised version of resolution and memo, plans for April 25 Council meeting

Hank: Most important "win" is putting responsibility for reporting on progress on City Manager. Emmet: Especially supports prescriptive prioritization of climate action as in the last item (about businesses)

Process going forward (following sign-off by sponsoring Council members): Cara will put this into the agenda system so it's formatted, along with her report

Discussed which council members are committed, or likely to commit

Rachel and Hank will coordinate public comment, suggest promotional strategy.

Climate dashboard

Jerri summarized presentation by KLA, a company that specializes in creating dashboard websites for municipalities to track/report on climate action. Cara will have update after April 25.

Matt asks about GHG inventory, which is part of his professional work. Cara will get in touch with him for possible help figuring out GHG accounting spreadsheets inherited from Kumar Jensen. Joel points to CARP document for some metrics

Brian is working on zero waste metrics, what IT is capable of, investigating company that works for Austin, Portland, other cities, will want to consider how would this be integrated into a more general dashboard.

Other Earth Month events

Opportunities to communicate with public officials about the climate resolution could include: Milo: E-Town Sunrise walk out on Earth Day; ETHS climate conference, when youth will be encouraged to contact public officials

Rachel: 10-second film festival, TeachOut at NU

CARP implementation agenda

Brian: doorstep textile recycling memo to Council on April 25, plastic bag policies still awaiting Council direction.
