

#### 1. CALL TO ORDER/DECLARATION OF A QUORUM

#### 2. **PUBLIC COMMENT**

#### 4. **DISCUSSION**

#### Α. Discussion of Property Taxes by CFO Hitesh Desai

Hitesh Desai, CFO presented an overview of the Property Tax process. Property Tax levies are set by local taxing bodies. CFO Desai also talked about assessed values, equalization

factor, equalized assessed values, and property tax rate. He mentioned the total Equalized Assessed Value of properties in Evanston. The total tax levy is distributed amongst several government agencies, with City share (including Library) at around 20% of total levy. CFO Desai also talked about significantly higher assessed valuation three years ago which caused many to file appeals with the county. There was a discussion about Police and Fire pension levies, which are based on the recommended contributions in the actuarial reports.

### B. Approval of Ordinance 26-O-22

The budget amendment ordinance/memo to City Council was presented to the committee by CFO Hitesh Desai. The purpose of the budget amendment is to amend the budget for funds which exceeded the budgeted expenses at the fund level. There were questions by several committee members as to why some funds exceeded expenses. Staff explained some of the overages and assured to have a more detailed presentation during the City Council meeting. Committee members agreed that there could be an improvement in the presentation of the monthly financial reports. Committee member Livingston provided several recommendations to enhance monthly financial reports
