Sidewalk Cafe

John Stumbaugh, owner/applicant, submits for a sidewalk cafe permit for Evanston Pour, in the B1 Business District and oDM Dempster-Main Overlay District.

APPLICATION PRESENTED BY: John Stumbaugh, owner/applicant

DISCUSSION:

- L. Biggs asked if the number of tables shown on the site plan fits into the space.
- A. Schnur stated staff measured the area to confirm site plan details.
- Applicant stated a 6' wide path is maintained for pedestrians, noting the sidewalk is 18' wide.
- L. Biggs stated a bike rack may need to be moved or removed.
- J. Nyden stated there are planters around the street trees that cause a tripping hazard.
- L. Biggs stated they will look into the planters, the planters may need to be removed.
- J. Nyden stated the applicant needs to check with the Law Department regarding the ability to serve alcohol in the sidewalk cafe.
- Applicant stated they would like a year round sidewalk cafe, with tables and chairs stored on the sidewalk, pad locked.
- J. Nyden stated the tables and chairs will need to be removed if there is a snow event and the sidewalk needs to be cleared.
- J. Nyden asked how trash will be handled.
- Applicant stated a trash can will be provided near the door.
- C. Pratt asked if recycling will be available.
- Applicant stated yes.
- M. Callahan asked if the barrier will be permanent.

- Applicant stated the barrier will not be permanently attached to the sidewalk.
- L. Biggs encouraged the applicant to provide composting.
- L. Biggs made a motion to approve the sidewalk cafe, seconded by C. Pratt.

Upon a voice vote of 10-0, the Committee approved the sidewalk cafe.
