#### 4. DISCUSSION

#### A. Q1/March 2022 Financials

Hitesh Desai, CFO went over 1st Quarter Financials. He explained that revenues in many of the funds, including General Fund, are higher than target because of the first installment of property taxes being collected. He also mentioned that the actual fuel expense could be higher than budget for FY 2022. City of Evanston is expected to receive the second installment of ARPA funds later this month. Parking revenues are slightly under budget but are expected to increase as we continue our transition to pre-COVID-19 conditions. CFO Desai suggested to use a portion of GF excess surplus to a transfer from General Fund to the Solid Waste Fund to supplement fund.

Committee member Reiches offered some suggestions as to how the monthly financial report structure could be improved. Councilmember Nieuwsma commented on the structure as well and suggested a more condensed version highlighting major funds.

#### B. Budget Amendment Process for 2022

Staff will continue to update the Finance & Budget Committee on a monthly and quarterly basis to inform of any possible overages in expenses.
