The Social Services Committee and staff recommend approval by the Human Services Committee of 2022 Emergency Solutions Grant (ESG) allocations totaling \$154,945: \$128,324 to Connections for the Homeless, \$15,000 to the YWCA Evanston/North Shore, and \$11,620 to the City of Evanston. The Human Services Committee recommendation will go to City Council on July 25, 2022.

Councilmember Reid requests that the Human Services Committee consider forwarding the foregoing item to the City Council for consideration. Per Councilmember Reid's referral, Ordinance 54-O-22, modifying Title 9, Chapter 5, Section 18-4 "Resisting or Interfering with Police" specifies that a person will violate this ordinance if resisting or interfering with the officer's duties in relation to criminal code enforcement, and in any way will physically prevent the officers from doing their lawful duty. The proposed modification to the Ordinance deletes the language when a person "in any way" "offers" and "attempts to rescue any person in the police custody" from the Code as the police officer discharges his/her lawful duty.
