RECIPIENTS OF THE 2010 INTERNATIONAL ASSOCIATION OF CHIEFS OF POLICE COMMUNITY POLICING AWARD



The International Association of Chiefs of Police is the world's oldest and largest organization of police executives, with more than 20,000 members in more than 140 different countries. In 1998 the IACP's Community Policing committee developed the Community Policing Award to recognize outstanding community policing initiatives by law enforcement agencies worldwide. Evanston's Safer Neighborhood Area Project (SNAP) was selected as the winner for police agencies serving a population of 50,001 to 100,000. The combined efforts of the Evanston Police Department, the City of Evanston Transportation and Engineering Division and the Housing Authority of Cook County resulted in a nearly 70% reduction in calls-for-service in the project area. The SNAP project was honored as an example of community policing best practices and recognized for the "meaningful change that can occur when law enforcement officials and their communities are empowered to utilize all available resources for crime prevention and improvement of quality of life."

Evansion is the 14th-largest city in Illinois, with a population of 74,239 and an area of 8.5 square miles. It is culturally and economically diverse. The city's rich mix of businesses, light industry and institutions employs 40,000 workers. A third of the housing stock is single-family houses, and half of Evanston's nearly 30,000 housing units are owner-occupied. The city boasts 93 neighborhood parks and beaches, excellent public transportation, shopping, entertainment, two hospitals, 86 churches and synagogues, a modern public library, many cultural centers and museums, and is home to Morthwestern University.

Evanston is bordered by the City of Chicago on the south, Lake Michigan on the east, the Yillage of Wilmette on the north, and the Yillage of Skokie on the west. It is a nome-rule community with a council/manager form of government. The city manager is appointed by the elected mayor and nine aldermen.

The Evanston Police Department

Evanston's full-service police department first achieved acclaim in 1929, when it established the nation's premier traffic-accident prevention bureau under the direction of Lieutenant Frank Kreml. Traffic-control innovations led to the department's being named the United States' most traffic-accident-free city for five consecutive years. Kreml later became director of the Northwestern University Traffic Institute.

Similarly, the department's Victim Witness Program was one of the nation's first (1976) police-based advocacy units. It, too, received national recognition, serving as a model in crisis intervention, counseling, and support and referral services.

Today the department maintains its tradition of innovation in the areas of communication, youth programs, crime prevention, and community-oriented policing.

Partnership Policing

The department's strong commitment to community-oriented problem-solving policing began in 1980, with an LEAA-funded project titled "The Police-Community Comprehensive Crime Prevention Program." Many of the community-focused strategies developed in the early 1980s continue today, such as partnerships with community and neighborhood organizations, foot patrols, bottom-up planning and problem-solving, school liaisons and extensive crime prevention programs. The department continues to broaden the scope of its community-oriented and problem-solving philosophy and methods under the "Partnership" logo.

Services

Police services currently include 24-hour preventive patrols and emergency response, an enhanced 911 emergency communication system, traffic and parking enforcement, criminal investigations, victim services, youth outreach, drug and gang enforcement, crime prevention, community partnerships and problem-solving, animal control, and police chaplain services.


Personnel Strength

The department has grown considerably since 1863, when village butcher Robert Simpson became the newly-incorporated Town of Evanston's first and only police officer. In fiscal year 2009-2010 (beginning March 1, 2009), the department's authorized personnel strength was 217.50 full-time employees. The 165 sworn personnel consisted of the chief of police, three deputy chiefs, eight commanders, 19 sergeants, a complement of 134 police officers and 52 full-time and one part-time civilian staffing various positions in the Department

Calls for Service

In 2010, Evanston police received 35,991 calls for service. Approximately 20% were related to verified incidents of crime, while 80% were non-crime-related issues. The majority of calls were related to investigations of unverified reports of crime (alarms, suspicious persons, noise, etc.) and activities not related to crime (disturbances and disputes, animal complaints, parking enforcement, traffic accidents, tows, persons missing or in need of assistance, lost and found property, and other miscellaneous services).

Office of Professional Standards

Complaint Register (CR)

The Office of Professional Standards (OPS) is responsible for investigating allegations of misconduct against the department or any of its members. These investigations are called complaint registers (CRs). Misconduct by department personnel must be detected, thoroughly investigated, and properly adjudicated in order to maintain public confidence and departmental integrity.

Personnel in OPS register and investigate all allegations. The results then are reviewed by supervisors, who submit recommendations to the chief of police regarding case dispositions and/or disciplinary actions. The chief makes the final determination of each case, based on his review of all recommendations.

OPS contacts the complainant in each case, to review and explain its disposition. Of the 35,991 calls for service received by the department during 2010, OPS investigated 23 incidents involving 23 allegations against 30 police officers.

Departmental Inquiry (DI)

In 2010 the Evanston Police Department began a system of tracking and recording all complaints. Complaints that are minor in nature are classified as Departmental Inquiries and are handled by the first line supervisors and not OPS investigators. The results and recommendations of the immediate supervisor are submitted to the Chief of Police through the chain of command. The chief makes the final determination of each case based on his review of all recommendations. In 2010 there were 43 Departmental Inquiries recorded.

Administrative Reviews (AR)

OPS officers also investigate allegations of misconduct made by an employee against the police department or any of its members. These internally-initiated investigations are called administrative reviews (ARs). During 2010, 65 ARs were investigated.

Use of force and resisting arrest are two other types of incidents routinely investigated by OPS.

Use of Force

Police officers are permitted to use force at a level they deem reasonable and necessary to protect others and/or themselves from bodily harm or to affect the arrest of a person who physically resists. However, physical force is to be used as a last resort and only after other reasonable alternatives have been exhausted or clearly would be ineffective. Judgment in these matters is not arbitrary, but is governed by state law, departmental policy and procedure, national law enforcement standards and police training.

Whenever physical force beyond mere restraint is used, each officer involved must file a report for review. The department investigates each use-of-force report. During 2010, it investigated 41 use-of-force incidents involving 61 officers.

Resisting Arrest and Obstructing a Police Officer

Last year the department reviewed 22 cases involving 41 officers. Twenty-two citizens were charged with resisting arrest. One case of obstructing a police officer involving three officers was reviewed. One citizen was charged with obstructing a police officer.

OPS investigated 23 incidents involving 23 charges (complaints) against 30 officers. 28 officers received one complaint each, while two officers received more than one complaint each. It should be noted effective that in 2010 the Evanston Police Department began a system of tracking and recording all complaints. Complaints that are minor in nature are classified as Departmental Inquiries and are handled by the members' supervisors and not OPS investigators. In 2010 there were 43 Departmental Inquiries recorded.





Complaint Registers and Administrative Reviews





The course consists of 12 weeks of classes, a Communications/E911 seminar, and a ride-along with a patrol officer.



Traffic Safety Challenge

In 2010, the Traffic Bureau competed in the State of Illinois Traffic Safety Challenge sponsored by the Illinois Association of Chiefs of Police. As a part of our entry, our efforts in the areas of Speed Enforcement, Occupant Restraint, and Impaired Driving were outlined and presented. The following categories were examined:

Enforcement Activity

As a result of the efforts in the Traffic Safety Challenge, the Traffic Bureau won second place in the competition. The prize for second place was one hand held radar unit plus 15 polo shirts.

Traffic Stop Data Collection

During March of 2010, the results of the fourth year of traffic stop data were released. The data revealed that the ratio between stops by the Evanston Police Department and the Northwestern University Center for Public Safety benchmark is 1 to 1. The likelihood of minority drivers being stopped is equal to their presence in the driving population. See Section III.

Civil Enforcement Task Force

The Civil Enforcement Task Force – comprised of various city departments, i.e. police, fire, human relations, community development – completed its eleventh year of working together to ameliorate nuisance properties.

Operation Hard Swipe

From April through September 2010, the Neighborhood Enforcement Team (NET) along with investigators from the Cook County Sheriff's Police, Cook County State Attorneys Office, United States Department of Agriculture, Northbrook Police Department and Wilmette Police Department conducted an undercover operation targeting street level narcotics sales as well as narcotic sales and LINK card fraud from a grocery store in Evanston. Undercover officers received approval from the Courts to utilize an eavesdropping device during the course of this investigation.

During this operation, officers purchased/seized 26.6 grams of crack cocaine, 10.8 grams of heroin, 23.1 grams of ecstasy, 354.8 grams of cannabis, five (5) handguns, one (1) shotgun and \$23,557 in US currency. This operation succeeded with the arrest of 36 individuals and the execution of four (4) search warrants.

Other Notable Narcotics Investigations

February 2010 – working off of a neighborhood complaint of drug sales, NET arranged for undercover purchases from said location. This culminated in an execution of a search warrant with the arrest of the individual and the seizure of 900 grams of cannabis and \$5,000 US currency.

March 2010 – working off a tip from an anonymous citizen of the illegal transportation of narcotics, NET established surveillance on the suspect and corroborated the information. A traffic stop was conducted resulting in the arrest of the subject and the recovery of 4431 grams of cannabis.

JULY 2010 – NET officers received many complaints from citizens at a community meeting regarding the illegal sales of narcotics at a specific residence. Undercover purchases were made that culminated in the execution of a search warrant with the arrest of the individual and the recovery of 6,670 grams of cannabis.

December 2010 – NET officers were alerted to a known gang member selling illegal drugs. The investigation culminated in the execution of a search warrant that resulted in the arrest of the gang member and recovery of 1,263 grams of cocaine and 389 grams of cannabis

Youth Services Program

The Youth Services Program is designed to enhance the police department's response to juvenile crime and families in youth related incidents. Services include crisis intervention, family case assessments, juvenile court liaison as well as intervention and prevention services for youth and their families. The lines of service in the program are counseling, community service, restorative justice and neighborhood youth outreach. The primary focus is to assist parents and address the youth's behavior oftentimes which is ungovernable or delinquent. The community service and restorative justice programs are designed to deter first or second time youth offenders from engaging in any further criminal or delinquent behavior. Restorative Justice is a victim-center response to crime that allows the victim, the offender, their families and representatives from the community to come together to address the harm that has been done by the juvenile offender. Lastly, the Neighborhood Youth Outreach Program allows outreach workers to engage 'high risk' youth and young adults on their "turf" in the community. Workers provide informal counseling/mentoring, opportunities for appropriate activities, gang/youth disturbances intervention, academic advocacy, life skills development and assistance in seeking employment.

The Police Chaplaincy Program

TRAFFIC STOP DATA REPORT

On July 18, 2003, Governor Blagojevich signed a traffic stop data collection law. This law created a four-year study to collect data on traffic stops as a methodology to identify racial bias. The study began January 1, 2004. The data is collected and compiled by the Illinois Department of Transportation. Northwestern University's Center for Public Safety conducts the analysis.

The following charts reflect the data for Evanston traffic stops. The data shows that the likelihood of minority drivers being stopped is equal to their presence in the driving population.





REFERENCE: Evanston Police Record Significant Drop in Crime for Third Consecutive Year

While other communities throughout the nation may have seen a rise in crime between 2009 and 2010, the City of Evanston has achieved another consecutive year signifying a decline in major part-one crimes. The Evanston Police Department remains committed and resolute in conducting in-depth investigations, and deceasing the frequency of homicides, which rose from 1 in 2009 to six in 2010. Illustrating significant declines were part-one crimes consisting of; robbery which was down a 17.%, aggravated battery & assault down 20.3%, burglary down a significant 21.7%, theft down 8.1% and motor vehicle theft down 31.3%. Criminal sexual assaults showed no increase remaining at 8 incidents, while arson rose slightly from 12 to 14 incidents equaling an increase of 16.7%. This statistical analysis equates to a year to date comparison aggregate for 2009 to 2010 indicating a total overall decline in crime of 12.4%.

Contributing to this success is the Evanston Police Department's ability to gather crime data, analyze trends and allocate police resources, to expediently focus on areas and individuals. The Evanston Police Department believes it is critical that all police efforts to address crime and quality of life issues be timely, specifically nuanced in the delivery of police services, and judicious in their application.

Fostering this concept, each week the Evanston Police Department employs a CompStat approach, designed to address and analyze all criminal activity in Evanston. During these CompStat sessions also known as "Deployment Meetings", crime analysis maps are presented, trends are discussed, and the previous week's deployment efforts are analyzed. Command staff personnel then review the most current statistical crime category summaries and develop specific deployment strategies designed to expeditiously impact crime in designated geographic areas.

Another important component in successfully addressing crime and quality of life issues has been the Evanston Police Department's desire to actively establish symbiotic relationships with thirty community groups throughout Evanston. Through these community ties information is exchanged, neighborhood events are held, and the police community partnership is strengthened.

The Evanston Police Department also believes it is extremely important to be transparent, have information accessible to the public, and continually communicate as an agency. This is accomplished by officers attending public meetings, sending information via listserve's, and by publishing information on the City of Evanston's website incorporating monthly crime statistics, the EPD Daily Crime Bulletins, and crime prevention publications.

Additionally, in 2010 the Evanston Police Department received international recognition from the International Chiefs of Police Association, for the Safer Neighborhood Area Project. SNAP employed two strategies for preventing crime and increasing safety. Crime prevention through Environmental Design (CPTED), and community based policing measures.

The project was comprehensive and included police, governmental agencies and citizens in a collaboration that specifically focused on areas troubled by chronic crime and disorder. A SNAP Team comprised of CPTED specialists defined project goals and supported participation between police, stakeholders, service agencies, and local businesses.

The Evanston Police Department would like to thank the citizens of Evanston for their continuing support and commitment to the "Police Community Partnership", which is a key component to the crime reduction strategy.
