I recognize the badge of my office as a symbol of public faith, and I accept it as a public trust to be held so long as I am true to the ethics of the police service.

I will constantly strive to achieve these objectives and ideals, dedicating myself before God to my chosen profession – law enforcement.





Office of Professional Standards

Complaint Register (CR)

The Office of Professional Standards (OPS) is responsible for investigating allegations of misconduct against the department or any of its members. These investigations are called Complaint Registers. Misconduct by department personnel must be detected, thoroughly investigated, and properly adjudicated in order to maintain public confidence and departmental integrity.

Personnel in OPS register and investigate all allegations. The results then are reviewed by supervisors, who submit recommendations to the Chief of Police regarding case dispositions and/or disciplinary actions. The Chief makes the final determination of each case, based on review of all recommendations. OPS forwards a letter of disposition to each complainant regarding the case outcome.

Of the **37,403** calls for service received by the department during 2014, OPS investigated **10** complaint registers involving 10 allegations.

Departmental Inquiry (DI)

In 2014, the Evanston Police Department continued a system of tracking and recording all complaints. Complaints that are minor in nature are classified as Departmental Inquiries and are handled by first line supervisors. The results and recommendations of the immediate supervisor are submitted to the Chief of Police through the chain of command. The Chief makes the final determination of each case based on review of all recommendations. In 2014, there were 28 Departmental Inquiries recorded.

Administrative Reviews (AR)

OPS members also investigate allegations of misconduct made by an employee against the police department or any of its members. These internally initiated investigations are called Administrative Reviews. In 2014, there were **86** Administrative Reviews recorded.

Use of Force

Use of Force and Resisting Arrest are two other types of incidents routinely investigated by OPS members. Police officers are permitted to use force at a level they deem reasonable and necessary to protect others and/or themselves from bodily harm or to affect the arrest of a person who physically resists. However, physical force is to be used as a last resort and only after other reasonable alternatives have been exhausted or clearly would be ineffective. Judgment in these matters is not arbitrary, but is governed by state law, departmental policy and procedure, national law enforcement standards and police training.

Whenever physical force beyond mere restraint is used, each officer involved must file a report for review. The department investigates all Use of Force reports. During 2014, there were 39 Use of Force incidents reported

Resisting Arrest and Obstructing a Police Officer

Last year (2014) the Department reviewed 17 cases of resisting and obstructing.





CPAC Summary

The Office of Professional Standards meets with members of the Citizen's Police Advisory Committee (CPAC) once a month. The 6 member committee participated in 12 scheduled meetings. In 2014 a total of 37 cases were reviewed. After the review process/session the results are forwarded to the Human Services Committee.

- Of the 37 cases that were reviewed, there were 8 instances where the members' votes were **not** unanimous (21.62%).
- In the above mentioned instances, 6 of the 8 were debates over the disposition of "unfounded" vs. "exonerated". <u>Unfounded</u> (allegations were false or no credible evidence to support the allegations. <u>Exonerated</u> (incident occurred but was lawful or proper).
- The remaining 2 instances were debates over the disposition "not sustained" (insufficient evidence to prove or disprove the allegations) vs. "exonerated".
- When the members of the Committee did not agree on the final disposition, the members voiced their opinions and noted on their packet their desired disposition.

NOTE: There were no instances where the committee entered a decision of Sustained vs. Not Sustained


II. HIGHLIGHTS OF 2014

Police and Citizen Awards

The police department encourages all police officers, civilian personnel, and the Evanston community to bring to the attention of the chief of police outstanding police work or service to the community by any officer, civilian employee or citizen.

Police Social Services Bureau - Youth Services Program

Evanston Police Department Youth Services are designed to enhance the police department's response to juvenile crime and families experiencing non-criminal youth-related crises. Youth Services Advocates work together with Sworn Officers and Juvenile Detectives in order to intervene upon youth-related crisis and crime. Services include follow-up with parents and guardians on incidents involving juveniles, youth-related Family Crisis Counseling, Youth Behavioral Assessments designed to identify the underlying causes of Youth behavior as well as effective family responses and social or community services. Youth Services collaborates with the Juvenile Court, Probation Services, Schools and other community social service providers in order to coordinate multiple and complex services and recommendations for youth offenders and their families. Youth Services offers Community Service and Restorative Justice Programs which provide early intervention and alternative-to-court dispositions that connect youth and their family with the community and provide a learning experience designed to deter youth offenders from engaging in further criminal or high-risk behavior.

Youth Services participates in family and youth-related community activities and committees that promote and support Evanston youth in becoming productive citizens and members of our community. Youth Services promotes community involvement in addressing youth crime and offers training for volunteers who participate in Restorative Justice Family Conferencing. Finally, Youth Services enhances community safety by coordinating CAB – Community Accountability Board – that addresses chronic truancy through family intervention and a school-community team approach.

NET Notable Events for 2014

<u>January</u>

On 1/24/2014 the NET Unit executed a search warrant on a suspected target in the 6900 block of North Sheridan Road, Chicago after developing information about narcotic sales in the Evanston area. The subsequent search warrant execution leads to the recovery of approx. 14 grams of crack cocaine and two semi-automatic handguns (Ruger 45 cal. and Smith Wesson 40 cal.). The subject was arrested and subsequently charged with PCS and intent to deliver, UUW by felon, No valid FOID for weapon and ammunition and misdemeanor possession of cannabis.

On 1/23/2014 NET Unit assisted in the arrest of a subject in the 700 block of Hinman after an encounter with him and another subject from an investigative traffic stop incident. Officers recovered approx. 1,224 grams of cannabis and 4.2 grams of cocaine from subject's residence.

NET Unit Detectives followed up with subsequent court proceedings on a UUW arrest for two defendants, which Cook County ASA office is initially pursuing maximum sentencing on felony charges against both subjects.

February

On 2/5/14, NET Unit executed a narcotics search warrant in the 7400 block of north Ridge, Chicago, subsequent an unrelated drug arrest/investigation in Evanston. The search warrant resulted in the recovery of approx. 2.3 grams of cocaine and 2.1 grams of cannabis and the arrest of a targeted suspect, who was also a gang member affiliated from Chicago.

N.E.T. Investigators also arrested several subjects for possession of cannabis (misdemeanor) as result of investigative street/traffic stops, of which two subjects with gang affiliation.

N.E.T. investigators also conducted surveillance on a drug TIP in the area of 100 Grey Ave, Evanston that resulted in the arrest of subject for possession of approx. 9 grams of cannabis.

On 2/25/14, N.E.T. Unit executed a narcotics search warrant in the 2100 block of Jackson that resulted in the arrest of the targeted subject and the recovery of 18.7 grams of cannabis, 13 tabs of LSD, 1.2 grams of DMT and 2.7 grams of Hashish along with suspected drug funds. The subject was charged with 3 felony counts and 2 misdemeanors.

On 2/26/14, N.E.T. Unit executed a narcotics search warrant in the 7400 block of north Oakley, Chicago and arrested a targeted subject. Approx. 170.3 grams of cocaine was recovered along with suspected drug funds. The subject was charged with felony PCS and PCS w/intent to deliver.

March

On 3/5/14, NET Unit Detectives recovered a .22 caliber handgun from information provided from a confidential informant during an unrelated narcotics investigation.

On 3/21/14, NET Unit Detectives arrested suspect for PCS (possession of Adderall 21.2 grams) during an investigative street stop in the 1800 block of Crain, Evanston..

On 3/26/14, NET Unit Detectives arrested known gang member on an outstanding misdemeanor warrant in the 2000 block of Grey, which the offender also battered a Patrol Officer by spitting on the officer and subsequently was charged with battery to P.O. and underage consumption of alcohol.

On 3/27/14, NET Detectives arrested a subject for PCS (approx. 5.3 grams of crack cocaine) and PCS w/intent to deliver during an investigative traffic stop in the 300 block of Custer. The subject also battered officers and physically resisted arrest during the incident so he subsequently was charged with battery to PO, two counts of resisting arrest and traffic violations. The subject's vehicle was seized pending forfeiture proceedings.

April

On 4/2/2014, NET Unit executed a narcotics search warrant for targeted subject in the 1000 block of Dodge subsequent to a narcotics investigation. NET Detectives recovered approx. 12 grams of cocaine and 2.5 grams of cannabis from the residence and he was charged with Felony PCS and possession w/intent to deliver and misdemeanor possession of cannabis.

On 4/7/2014, NET Detectives were investigating a drug TIP in the 1600 block of McDaniel, which two renters were suspected of dealing drugs from their basement apartment. Detectives conducted consent to search at the location but did not locate any drugs. Detectives recovered approx. 350 rounds of ammunition that the landlord claimed was her deceased husband (no criminal charges).

On 4/25/2014, NET Detectives responded to a drug complaint at Love Lace Park 2700 Gross Point Road and arrested two subjects for possession of cannabis, which approx. 14.1 grams of cannabis was recovered from both subjects, and both subjects were issued C-tickets.

NET Detectives conducted undercover surveillance on targeted a subjects reference on-going narcotics investigation. Detectives also met with outside law enforcement personnel to exchange intelligence information on subject with regards to this narcotics investigation.

May

On 5/2/14, NET Unit Members assisted IDOC Parole Agents with a parole compliance check on several IDOC parolees in the 1900 block of Jackson. While at the location, NET members and IDOC recovered a .32 caliber Harrison & Richardson Revolver from the residence. The arrested subject was also a resident at the location and he subsequently was charged with two misdemeanor counts of UUW.

On 5/7/14, NET Unit Members executed a narcotics search warrant after an initial narcotics investigation on a targeted subject in the 1400 block of Brummel. The search warrant resulted in the arrest of the targeted subject and another resident. NET members recovered a 9 MM Bryco semi-auto handgun and ammunition. Also recovered was 30 grams of cannabis, which an adult was charged with two misdemeanor counts of UUW and charged with misdemeanor possession of cannabis. As a result of subject being on parole and charged with UUW by felon, he was also arrested on felony parole violation warrant at the request of IDOC Parole Department.

On 5/8/14, NET Unit Members arrested a suspect for possession and w/intent to deliver cannabis (approx. 33 grams) during a traffic stop investigation in the 1700 block of Howard Street. The subject was subsequently charged with two felony counts for possession and w/intent to deliver cannabis and a petty offense (traffic violation).

On 5/21/14, NET Unit Members arrested a person wanted for violation of order of protection by Cook County Sheriff Department, and subject was taken into custody in the 1900 block of Jackson.

On 5/26/14, NET Unit Members were patrolling the area of Lake and Dodge when they observed a large group of male subjects attacking two male victims in the streets. NET

members apprehended two adult suspects and three juvenile subjects that were turned over to the Juvenile bureau. The adult suspects were subsequently charged with misdemeanor reckless conduct and mob action.

On 5/30/14, NET Unit Members executed a narcotic search warrant in the 9100 block of Ewing Skokie after an initial narcotic investigation on a suspected target. The search warrant service resulted in the recovery of 28 grams of cannabis and subsequent arrest of target subject. The arrestee was charged with misdemeanor possession of cannabis and felony possession w/intent to deliver cannabis. NET members also served an active outside agency failure to appear felony warrant from Skokie PD on the subject.

<u>June</u>

On 6/5/2014, NET Unit Detectives were patrolling for reported gang activity when they observed known gang member in violation of city ordinance (possession of open alcohol), which he subsequently was stopped and arrested for the city ordinance violation.

On 6/9/14 NET Unit Detectives were in the area of Brummel/Custer when they stopped two subjects matching a flash message of robbery suspects involved in a strong arm robbery incident at Damen & Birchwood from Chicago PD. The subjects stopped were known gang members and were subsequently identified from a show up as the two robbery suspects. The subjects were turned over to CPD.

July

On 7/2/2014, NET Unit Detectives along with agents from ATF and Cook County Sheriff's Police executed a search warrant in the 600 block of Grove. Three handguns and two rifles were recovered and a subject was subsequently charged with Felony UUW. On 7/17/14, Detectives recovered three more rifles and one more handgun that belonged to the subject.

On 7/9/2014, NET Unit Detectives were patrolling a known gang deployment area when they observed several known members of the ABM street gang driving in the 1900block of Jackson. After observing a traffic violation, the detectives stopped the vehicle and a subsequent search revealed a small amount of Cannabis and a loaded handgun. An ABM member was charged with Aggravated U.U.W. and a female subject was charged with misdemeanor Possession of Cannabis.

<u>August</u>

On 8/8/14, NET Detectives arrested a gang member for possession of cannabis (approx. 4 grams) near Dempster & Fowler, Evanston.

NET Unit Detectives also arrested two known gang members on outstanding felony warrants in the 1400 block of Emerson on 8/21/14 and 1900 Howard on 8/26/14.

On 8/26/14 NET Detectives arrested known gang member for PCS and w/intent to deliver, which the subject was in possession of approx. 3.5 grams of cannabis, 6.6 grams of crack cocaine and 55 Hydrocodone pills.

September

On 9/2/14, NET Detectives conducted a weapon & drug investigation on a suspected target in the 4900 block of Hull Skokie, IL, which resulted in detectives executing a search warrant at the above listed location and recovering a loaded Intratec Tec 22 (.22 caliber) and approximately 49 grams of cannabis. The target was charged with UUW, No FOID for handgun and ammunition and felony possession and w/intent to deliver cannabis.

On 9/4/14, NET Detectives assisted IDOC Parole Agents with a parolee compliance check operation within Evanston and nearby jurisdictions. Detectives and IDOC Parole Agents performed 29 parolee compliance checks, which resulted in numerous parolee contacts.

On 9/12/14, NET Detectives arrested a subject for an aggravated battery investigation as a result of an outside police agency alert from Highland Park PD. The subject was taken into custody in the 2300 block of Emerson, Evanston and released Highland Park PD.

On 9/19/14, NET Detectives executed a search warrant for drugs on targeted subject of an ongoing narcotics investigation in the 1700 block of west Estes Chicago. The narcotics investigation resulted in the recovery of approx. 25 grams of cannabis and subsequent felony criminal charges of possession and w/intent to deliver against target subject.

October

On 10/7/14, NET Unit members responded to an armed robbery incident in the area of Crain and Florence and subsequently were involved in the arrest of two male juvenile suspects and recovery of discarded replica of handgun that was used in the armed robbery. The male juvenile suspect, who was in possession of the handgun, was subsequently charged with armed robbery after being turned over to juvenile officers.

On 10/9/14, NET Detectives and TAC Officers along with Chicago PD SWAT Team executed a search warrant for weapons in the 1600 block of Farwell Chicago, which two assault rifles and a shot gun along with numerous rounds of ammunition were recovered. Two targeted subjects were arrested and subsequently charged with felony and misdemeanor charges for the unlawful possession of firearms and ammo.

On 10/17/14, NET Detectives arrested a documented GD gang member, reference a pending drug investigation for felony possession of controlled substance (cocaine) and with intent to deliver in the 1700 block of Crain.

During burglary deployment assignment, NET Detectives conducted an investigative stop on a suspicious suspect in the 1000 block of Garnett Street. The suspect was observed acting suspicious in the rear yards in the 1000 block of Garnett and subsequently was stopped by NET Detectives. Offender had in his possession a credit card in another female subject's name and was unable to provide an explanation for his whereabouts in the area. The suspect was turned over to detective bureau and subsequently was charged with possession of controlled substance (MDMA) but no charges filed for unlawful possession of credit card due to victim refused prosecution.

On 10/29/14, NET Unit members along with US Marshalls (Fugitive Task Force) and arrested a wanted felon on several outstanding felony warrants at his residence in the 9100 block of Keating, Skokie. The subject was wanted on warrants for PCS, CCSPD probation violation and felony drug conspiracy (delivery of approx. 350 grams of cocaine) by the Pennsylvania Attorney General's Office, which the subject had been a fugitive since 2008. During the circumstance of warrant arrest, the subject was in possession of approx. 23 grams of cannabis therefore he was charged felony possession of cannabis w/intent to deliver and misdemeanor possession cannabis.

November

On 11/21/14, N.E.T. Unit Detectives executed a search warrant on targeted subject for narcotics related investigation in the 1500 block of Dodge Ave. Detectives recovered approx. 2.7 grams of heroin and 1.8 grams of cannabis along with one spent 9MM shell casing and five live rounds of .22 caliber ammunition during their search of the residence.

N.E.T. Detectives also deployed for street robberies in the southeast areas of beat 72 during this period.

December

On 12/5/14, N.E.T. Detectives assisted Homeland Security Special Agents and Cook County Sheriff Gang/Narcotic Unit on a drug investigation in the 1500 block of Sherman, Evanston. During a surveillance of a suspected drug transaction with an unknown target subject, officers subsequently took into custody a subject, who was in possession of approx. 7.8 ounces of Meth.

On 12/9/14, N.E.T. Detectives assisted Chicago Police Narcotic Unit with a controlled narcotic delivery in the 1000 block of South Blvd, Evanston, which the controlled delivery contained approx. 2,449 grams of cannabis. At the aforementioned location, CPD and N.E.T. Detectives executed the search warrant and arrested the offender.

On 12/29/14, N.E.T. Detectives recovered a .22 caliber High Standard Derringer and 22 rounds of ammunition as a result of a follow up investigation on a drug arrest incident.

On 12/11/14 thru 12/30/14, N.E.T. Detectives assisted Chicago Police with an on-going drug investigation, which resulted in 5 arrests and the recovery of over 160 grams of cocaine.

The Forensic Services Bureau oversees the Property Bureau and the Evidence Technician program.



Northeastern Illinois Regional Crime Lab (NIRCL)

The City became a member of the Northeastern Illinois Regional Crime Lab in September of 2014, moving away from the use of the Illinois State Police Crime Lab. This move was prompted in order to improve turnaround times from the state lab and increase certain types of evidence processing that were not available through the state lab.

Since joining NIRCL, evidence turnaround times have increased markedly and can be measured in weeks rather than years. This change has resulted in better case investigations, better courtroom presentations, a faster clearance/closure rate for investigations and hopefully fewer victims of crime due to the offenders being identified and arrested in a quicker manner.

Larry Miller / Latent Print Identifications

During 2014 Officer Miller made 9 fingerprint identifications including 1 identification made assisting NORTAF on a Skokie murder case.

- 3 Burglary
- 3 Narcotics Violations
- 1 Felony Unlawful Use of Weapon
- 1 Vehicular Hijacking
- 1 Murder (NORTAF)

During the same time period, five fingerprint identifications were received from the Illinois State Police Crime Lab and two were received from the Northeastern Illinois Regional Crime Lab making for a total of sixteen fingerprint "hits".

Evidence technicians also collected DNA from four scenes² that were matched to suspects through the CODIS automated DNA database.

Drug Disposals

With the City becoming a member of the Northeastern Illinois Regional Crime Lab (NIRCL) in 2014, hundreds of items of drug evidence that had been held in property storage for years have finally been destroyed as one service that is provided to members by NIRCL. Numerous additional items will be submitted for destruction in 2015.

Subpoena Fulfillment

The Property Bureau completed 820 subpoena service requests in 2014.

Save-A-Star Drug Drop

In April of 2013, the department acquired a drop box from the Save-A-Star Foundation that facilitates public disposal of prescription and non-prescription drugs to prevent abuse and unsafe disposal.

The Property Bureau empties this box on a bi-weekly basis, packages, inventories and stores the contents for subsequent transfer to the DEA with the DEA handling the final disposal.

The Property Bureau processed 765 pounds of material collected from the box during 2014.

ATF e-Trace Submissions

A total of 88 firearms were taken in by the department in 2014 compared to 143 collected in 2013. EPD members inventorying these weapons are responsible for completing the ATF online e-Trace submissions. Not all firearms are traced, generally due to missing or incomplete serial numbers. The Property Bureau acts as the clearinghouse for ATF completed ATF traces disseminating the trace disseminating the trace information to the appropriate EPD personnel.



TRAFFIC STOP DATA REPORT

On July 18, 2003, Governor Blagojevich signed a traffic stop data collection law. This law created a four-year study to collect data on traffic stops as a methodology to identify racial bias. The study began January 1, 2004 and has continued. The data is collected and compiled by the Illinois Department of Transportation. Northwestern University Center for Public Safety (NUCPS) conducts the analysis.

The following charts reflect the data for Evanston traffic stops. The data shows that the likelihood of minority drivers being stopped is equal to their presence in the driving population.



From January 1st, 2014 through December 31, 2014, the Evanston Police Department investigated 2,604 crashes throughout the City of Evanston. Of the 2,604 crashes reported, 2,175 crashes occurred on Evanston roadways and 429 crashes occurred on private property. A 5% increase from 2013.

The 5% increase in crashes investigated in 2014 can be directly attributed to the winter weather conditions endured in 2014. Between January 1, 2014 and March 31, 2014 the Chicagoland area received a total of 65 ½ inches of snow. 36 1/2 inches more snow than 2013 in the same time frame. During this time frame, 713 crashes were investigated with 300 attributed to snowy/icy conditions versus 436 crashes investigated in 2013 with 68 attributed to snowy/icy conditions.





In 2014, of the 2,604 crashes reported, there were 247 crashes where at least 1 person had claimed an injury. A 14% decrease from the previous year and 18% since 2009. Serious injuries crashes where at least one party required medical transport to the hospital had decreased 21%, dropping from 173 in 2013 to 137 in 2014.

Contributing Factors to the Injury Crashes



All 247 injury crashes were reviewed. The above chart shows the contributing factors that led to the injury crash. Failing to yield the right of way and speed, which comprised 69% of the total injury crashes, were the top two contributing factors that led to the crashes. 9 of the 247 injury crashes were alcohol related.

OFFENSE SUMMARY


When comparing 2014 to 2013, Evanston's overall reported crimes against a person were down 20.8 percent. Deployment-related crime, which includes the categories of robbery, aggravated battery and burglary, decreased eight percent in 2014. Burglaries as an individual category decreased by just over five percent last year.

However, the increase in theft crimes caused the city's overall crime rate to increase by 0.6 percent in 2014. Theft crimes increased by 4.3 percent and motor vehicle thefts increased by 15.8 percent when compared to 2013 statistics. Many of the stolen vehicles were unsecured and appeared to have been stolen by use of a spare/valet key that was left inside the vehicle or a "jiggler" key. A "jiggler" key is a device thieves use to defeat locking mechanisms.

Crimes against a person decreased in 2014 as compared to 2013. Homicides decreased from four to one; reports of criminal sexual assault (CSA) decreased from 10 to three; arson decreased from 12 to five; robberies decreased from 61 to 54; and aggravated batteries decreased from 110 to 93.

Below is a chart of the overall part I crime trends in Evanston from 1985 to 2014. Part I crimes are the categories of murder, criminal sexual assault, robbery, aggravated battery/aggravated assault, burglary, theft, motor vehicle theft and arson. Part I crimes are typically researched by the public to determine the safety within a community.

The Evanston Police Department is consistently striving to reduce crime and improve the quality of life for its community members by employing community policing, deploying resources in areas with concentrated incidents, and partnering with outside agencies, both governmental and private, to reduce violence. VI. COFFEE WITH A COP



The Evanston Police Department participated in the national 'Coffee with a Cop' program, which started in 2011, as a way for community members to talk with police officers about any concerns or questions that they have. The "Coffee with a Cop" event builds upon the Evanston Police Department's community policing efforts within the city and provides a casual space for residents, business owners and other interested members of the community to chat with officers and ask questions, share concerns or simply talk about sports in a casual, friendly environment.

The first "Coffee with a Cop" event took place in June at Delbe's Corner in the 1100 block of Davis and the second event took place in September at Perla Café in the 1800 block of Dempster. Both events were successful in allowing officers to engage with residents of the community in a less formal setting and increase the lines of communication between the police and the community.

Please receive this as a note of appreciation and recognition of the good work by Officers Divine and DeLeon. Your officers responded to my appeal for help. A gentleman entered the counseling center, scattered magazines, and laid flat on the couch. He was not a client and I explained that we were not equipped to attend to his needs.
