## AN ORDINANCE

Amending Section 10-11-10, Schedules X(C), X(F), and X(I)  
of the Evanston City Code, 1979

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EVANSTON, COOK COUNTY, ILLINOIS:

SECTION 1: That the Evanston City Code, 1979, as amended, be and hereby is further amended by adding to Section 10-11-10, Schedule X, Limited Parking, Subsection (C), Two-hour Limit, 9:00 (nine o'clock) A.M. to 6:00 (six o'clock) P.M., except Sundays and National Holidays, the following:

Gaffield Place	South side, CTA tracks to Sherman Avenue
Hamlin Street	Both sides, CTA tracks to Sherman Avenue
Simpson Street	North side, CTA tracks to Sherman Avenue

SECTION 2: That the Evanston City Code, 1979, as amended, be and hereby is further amended by deleting from Section 10-11-10, Schedule X, Limited Parking, Subsection (I), Two-hour Limit, 9:00 (nine o'clock) A.M. to 6:00 (six o'clock) P.M., except Saturdays, Sundays and National Holidays, the following:

Simpson Street	North side, Ridge Avenue to Maple Avenue

SECTION 3: That the Evanston City Code, 1979, as amended, be and hereby is further amended by adding to Section 10-11-10, Schedule X, Limited Parking, Subsection (I), Two-hour Limit, 9:00 (nine o'clock) A.M. to 6:00 (six o'clock) P.M., except Saturdays, Sundays and National Holidays, the following:

Gaffield Place	South side, Maple Avenue to CTA tracks
Hamlin Street	Both sides, Maple Avenue to CTA tracks
Maple Avenue	Both sides, Foster Street to Noyes Street
Simpson Street	North side, Ridge Avenue to CTA tracks

SECTION 4: That the Evanston City Code, 1979, as amended, be and hereby is further amended by adding to Section 10-11-10, Schedule X, Limited Parking, Subsection (F), Exceptions, Paragraph (6), Residential Exemption Parking District "A", the following:

- Gaffield Place            South side, CTA tracks to Sherman Avenue
- Hamlin Street            Both sides, CTA tracks to Sherman Avenue
- Noyes Street             South side, Noyes Court to Sherman Avenue
- Simpson Street          North Side, CTA tracks to Sherman Avenue

SECTION 5:            That the Evanston City Code, 1979, as amended, be and hereby is further amended by adding to Section 10-11-10, Schedule X, Limited Parking, Subsection (F), Exceptions, Paragraph (8), Residential Exemption Parking District "G", the following:

- Gaffield Place            South side, Maple Avenue to CTA tracks
- Hamlin Street            Both sides, Maple Avenue to CTA tracks
- Maple Avenue            Both sides, Foster Street to Noyes Street

SECTION 6:            That ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 7:            That this ordinance shall be in full force and effect from and after its passage, approval and publication in the manner provided by law.
