AN ORDINANCE

Amending Section 10-11-9, Schedule IX(H) and IX(Q)  
of the Evanston City Code, 1979

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EVANSTON, COOK  
COUNTY, ILLINOIS:

SECTION 1: That the Evanston City Code, 1979, as amended, be and hereby is further  
amended by adding to Section 10-11-9, Schedule IX(H), ELEVEN O'CLOCK (11:00) P.M. TO  
SIX O'CLOCK (6:00) A.M., DAILY, NO EXCEPTIONS, the following:

- Lake Shore Boulevard      West Side, Lee Street to Greenleaf Street, October 1  
through April 30
- Lake Shore Boulevard      West Side, Dempster Street to Greenwood Street,  
October 1 through April 30

SECTION 2: That the Evanston City Code, 1979, as amended, be and hereby is further  
amended by deleting from Section 10-11-9, Schedule IX(Q), AT CERTAIN TIMES ONLY IN  
ACCORDANCE WITH THE FOLLOWING SCHEDULE, the following:

- Lake Shore Boulevard      East side, May 1 through September 30, 9:00 P.M. to  
6:00 A.M. (from Lee Street to Dempster Street)
- Lake Shore Boulevard      West side, May 1 through September 30, 11:00 P.M. to  
6:00 A.M. (from Lee Street to Hamilton Street)

SECTION 3: That the Evanston City Code, 1979, as amended, be and hereby is further  
amended by adding to Section 10-11-9, Schedule IX(Q), AT CERTAIN TIMES ONLY IN  
ACCORDANCE WITH THE FOLLOWING SCHEDULE, the following:

Lake Shore Boulevard	East side, May 1 through September 30, 9:00 P.M. to 6:00 A.M. (from Lee Street to Greenwood Street)
Lake Shore Boulevard	West side, May 1 through September 30, 9:00 P.M. to 6:00 A.M. (from Lee Street to Greenleaf Street)
Lake Shore Boulevard	West Side, May 1 through September 30, 9:00 P.M. to 6:00 A.M. (from Dempster Street to Greenwood Street)

SECTION 4: That ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 5: That this ordinance shall be in full force and effect from and after its passage, approval and publication in the manner provided by law.
