## AN ORDINANCE

Amending Section 10-11-17, Schedule XVII  
of the Evanston City Code, 1979

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EVANSTON,  
COOK COUNTY, ILLINOIS:

SECTION 1: That Section 10-11-17, Schedule XVII(A) of the Evanston City Code, 1979, as amended, be further amended to read as follows:

(A) Penalty: \$10.00 plus \$10.00 additional penalty if paid after the expiration of ten (10) days from the date of issue.

1. Expired parking meter 10-5-4-B

SECTION 2: That Section 10-11-17, Schedule XVII(B) of the Evanston City Code, 1979, as amended, be further amended to read as follows:

(B) Penalty: \$20.00 plus \$10.00 additional penalty if paid after the expiration of ten (10) days from the date of issue.

SECTION 4: That Section 10-11-17, Schedule XVII(E) of the Evanston City Code, 1979, as amended, be further amended to read as follows:

- (E) Penalty: \$100.00, plus \$50.00 additional penalty if paid after the expiration of ten (10) days from the date of issue:

Parking in spaces reserved for the mobility limited pursuant to subsection 10-4-11 (A).

SECTION 5: That Section 10-11-17, Schedule XVII(F) of the Evanston City Code, 1979, as amended, be further amended to read as follows:

- (F) Penalty: \$100.00, plus \$50.00 additional penalty if paid after the expiration of ten (10) days from the date of issue:

Parking in spaces reserved for the mobility-limited pursuant to subsection 10-4-11 (B).

SECTION 6: That Section 10-11-17, Schedule XVII of the Evanston City Code, 1979, as amended, be further amended by deleting sub-section G in its entirety.

SECTION 7: That ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 8: That this ordinance shall be in full force and effect from and after its passage, approval and publication in the manner provided by law.
