AN ORDINANCE

Amending Sections 10-11-10 and 10-11-18  
of the Evanston City Code, 1979

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EVANSTON, COOK  
COUNTY, ILLINOIS:

SECTION 1: That the Evanston City Code, 1979, as amended, be and hereby is further  
amended by deleting from Section 10-11-10, Schedule X (F), Exemptions, subparagraph 8. Residential  
Exemption Parking District "G", the following:

Leon Place                      North side, Asbury Avenue to Ridge Avenue

SECTION 2: That the Evanston City Code, 1979, as amended, be and hereby is further  
amended by adding to Section 10-11-18, Schedule XVIII, the following subsection:

(O)     District G: Eight o'clock (8:00) A.M. to five o'clock (5:00) P.M., Monday through  
Friday:

Leon Place                      North side, Asbury Avenue to Ridge Avenue

Those residents having a legal address on the portions of streets listed above are eligible to  
apply for and purchase a District G permit.

SECTION 3: That ordinances or parts of ordinances in conflict herewith are hereby  
repealed.

SECTION 4: That this ordinance shall be in full force and effect from and after its passage, approval and publication in the manner provided by law.

4. **Unscheduled draws on credit enhancements reflecting financial difficulties**
5. **Substitution of credit or liquidity providers, or their failure to perform**
6. **Adverse tax opinions or events affecting the tax-exempt status of the security**
7. **Modifications to the rights of security holders**
8. **Bond calls**
9. **Defeasances**
10. **Release, substitution or sale of property securing repayment of the securities**
11. **Rating changes**

Note: Some of the foregoing events may not be applicable to the Bonds.
