## AN ORDINANCE

Vacating A Portion of Clark Street
West of Maple Avenue and East of East Railroad Avenue
to Abutting Owners

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EVANSTON, COOK COUNTY, ILLINOIS:

SECTION 1: That the certain portion of Clark Street west of Maple Avenue and east of East Railroad Avenue legally described as:

THAT PART OF CLARK STREET, BEING A 66.00 FOOT RIGHT-OF-WAY LYING NORTH OF BLOCK 3, SOUTH OF BLOCK 2 IN THE CIRCUIT COURT PARTITION OF LOT 22 IN THE COUNTY CLERK'S DIVISION OF UNSUBDIVIDED LANDS, LYING NORTHEASTERLY OF EAST RAILROAD AVENUE AND LYING WESTERLY OF A LINE 7.00 FEET WEST OF AND PARALLEL TO THE WEST LINE OF MAPLE AVENUE, ALL IN SECTION 18, TOWNSHIP 41 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN THE CITY OF EVANSTON, COOK COUNTY, ILLINOIS.

SECTION 4: That this ordinance shall be in full force and effect from and after its passage, approval, and publication in the manner provided by law.
