AN ORDINANCE

Vacating A Portion of the Alley South of Clark Street
North of Church Street, East of
Maple Avenue and West of Benson Avenue

WHEREAS, the City of Evanston on July 6, 1959, pursuant to Ordinance 23-O-59 recorded as document 17 605 435 did vacate the below described real estate; and

WHEREAS, said vacation did reserve the right of public utilities "presently installed or which may be heretoeafter located therein" ("Utility Reservation"); and

WHEREAS, said utility reservation is not in the best interests nor necessary for the citizens of Evanston.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EVANSTON, COOK COUNTY, ILLINOIS:

SECTION 1: That the certain portion of real estate described as:

ALL OF THAT PART OF THE NORTH-SOUTH 20 FOOT ALLEY AND THE EAST-WEST 20 FOOT ALLEY VACATED PER DOCUMENT NO. 17605435 AND THE REMAINING NORTH-SOUTH ALLEY HERETOFORE VACATED, ALL IN BLOCK 18 IN THE VILLAGE OF EVANSTON, IN SECTION 18, TOWNSHIP 41 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

is hereby vacated to the City of Evanston as indicated by the words "hereby vacated" as shown on Exhibit A attached hereto and incorporated into this Ordinance.

SECTION 2: That the City of Evanston does hereby release and terminate the aforesaid Utility Reservation. **Northwestern University as owner of abutting property shall pay the sum of \$1.00 as compensation for said vacation and on such payment shall own the entire parcel vacated.**

SECTION 3: Said alley portion is hereby vacated and closed, inasmuch as the corporate authorities of the City of Evanston have determined that the public interest will be served by said vacation.

SECTION 4: That all ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 5: That this ordinance shall be in full force and effect from and after its passage, approval, and publication in the manner provided by law.



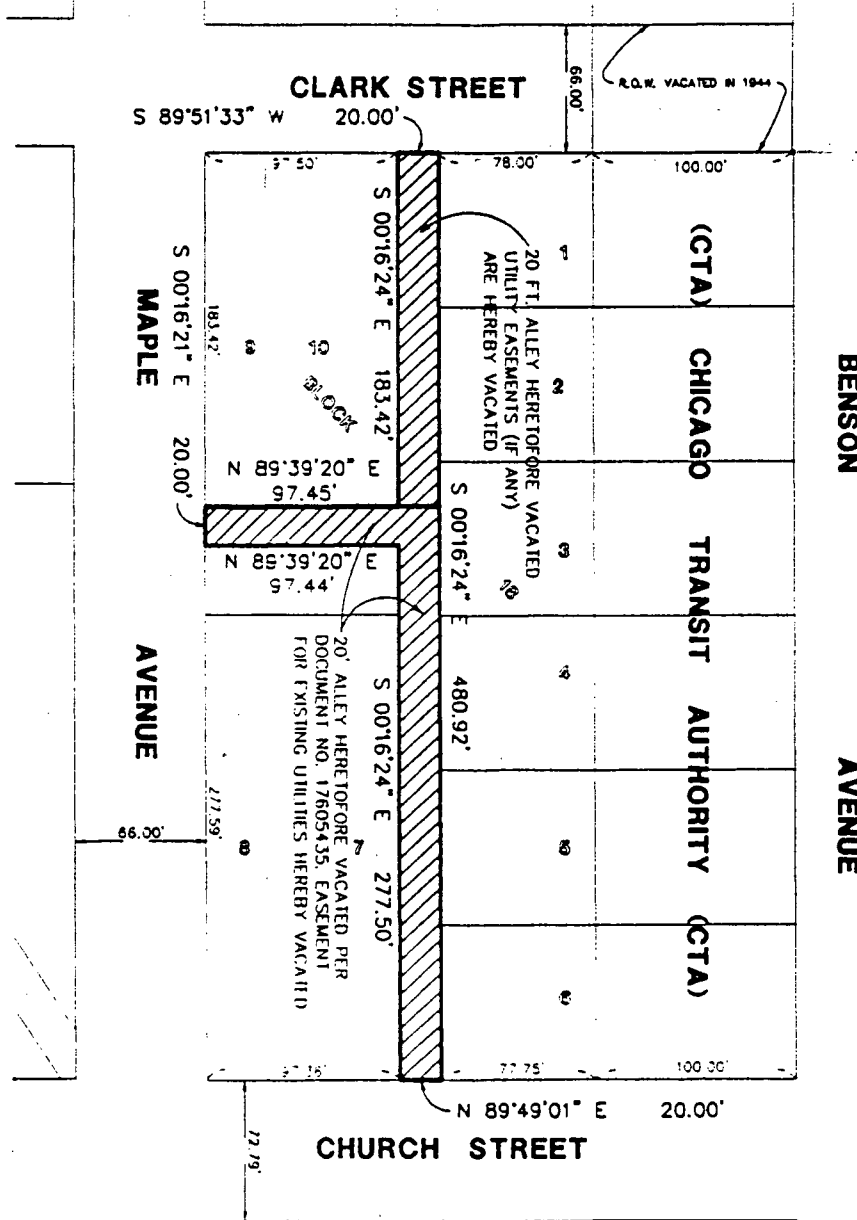
