AN ORDINANCE

Designating a Portion of the Public Alley North of Hillside Road and East of Princeton Avenue as Thayer Court

WHEREAS, the owners of 2718 and 2722 Crawford Avenue have requested that a portion of the public alley north of Hillside Road and East of Princeton Avenue be designated as a public street, Thayer Court; and

WHEREAS, the driveways at 2718 and 2722 Crawford Avenue ingress/egress from Thayer Alley, not Crawford Avenue; and

WHEREAS, Thayer Alley has a curb the same size/depth as the curb along Crawford and Thayer Avenues and equal drainage; and

WHEREAS, the Crawford Avenue addresses are misleading as there is not direct access to these addresses for emergency and nonemergency situations; and

WHEREAS, the City Council has determined it is in the best interest of the City to designate a portion of the public alley north of Hillside and East of Princeton Avenue as a street named Thayer Court,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EVANSTON, COOK COUNTY, ILLINOIS:

SECTION 1: That the portion of the public alley North of Hillside Road and East of Princeton Avenue legally described as follows:

THAT PART OF THE 16 FEET NORTHERLY-SOUTHERLY PUBLIC ALLEY ADJACENT TO LOTS 1, 2 AND 3 IN LILAC COURT SUBDIVISION OF LOTS 1, 2, 3, 4, 5, 6 AND 7 IN BLOCK 3 IN HIGHLANDS TERMINAL THIRD ADDITION, BEING A SUBDIVISION IN THE WEST HALF OF

SECTION 33, TOWNSHIP 42 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN IN THE CITY OF EVANSTON, COOK COUNTY, ILLINOIS.

SECTION 2: That a certified copy of said ordinance be recorded at the Office of Recorder of Deeds in Cook County, Illinois.

SECTION 3: That all ordinances or parts of ordinances in conflict herewith are hereby repealed.


SECTION 4: That ordinance shall be in full force and effect from and after its passage, approval, and publication in the manner provided by law.
