### AN ORDINANCE

Authorizing The City Manager to Negotiate A Sale of the Thirty-Five Foot (35') Strip of Land Immediately West of the CTA Purple Line Tracks, and Bounded by Clark, Church and Maple Streets in Evanston, Illinois and Authorizing the Publication of a Notice of Intent to Sell Certain Real Estate

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EVANSTON, COOK COUNTY, ILLINOIS:

SECTION 1: That the City Manager be and is hereby authorized and directed to negotiate the sale of the City's interests in the real estate legally described in Exhibit A and commonly known as the thirty-five foot (35') strip of land immediately west of the CTA Purple Line tracks, and bounded by Clark, Church and Maple Streets in Evanston, Illinois.

Pursuant to Section 1-17-4-2(B), an affirmative vote of two-thirds (2/3) of the elected aldermen is required to accept the recommendation of the City Manager on the negotiation authorized herein. The City reserves the right to reject any and all negotiations.

SECTION 2: Pursuant to Section 1-17-42(B) such Notice of Sale by negotiation must be published at least once in a daily or weekly newspaper in general circulation in the city.

The publication must not be less than 15 nor more than 30 days before the date on which the City Council shall consider the adoption of the ordinance approving the sale of the property.

**SECTION 4**: All ordinances or parts of ordinances in conflict herewith are hereby repealed.
