AN ORDINANCE

Amending Sections 10-1-7, 10-11-1, and 10-11-2
of the Evanston City Code, 1979

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EVANSTON, COOK COUNTY,
ILLINOIS:

SECTION 1: That the Evanston City Code, 1979, as amended, be and hereby is further amended by amending Section 10-1-7, SPEED REGULATIONS, to read as follows:

- (A) **State Speed Laws Applicable:** In accordance with Section 5/11-604 of the Illinois Vehicle Code, it is hereby determined that the speed limit on all streets within the City is established at 25 mph; exception: this limit does not apply to streets which are under the jurisdiction of the State of Illinois, nor does it apply to streets on which a separate speed regulation ordinance has been approved by City Council.
- (B) **Increasing Speed Limits:** It is hereby declared that the maximum speed limit upon those streets or portions of streets described in Schedule I, Section 10-11-1, shall be increased from the Citywide 25 mph limit to the limit therein stated.
- (C) **Decreasing Speed Limits:** It is hereby declared that the maximum speed limit upon those streets or portions of streets described in Schedule II, Section 10-11-2, shall be decreased from the 25 mph limit to the limit therein stated.

SECTION 2: That the Evanston City Code, 1979, as amended, be and hereby is further amended by amending Schedule I, Section 10-11-1, to read as follows:

10-11-1: SCHEDULE I; SPEED LIMIT INCREASED: In accordance with subsection 10-1-7(B) of this Title and when signs are erected giving notice thereof, the maximum speed limit shall be as set forth in this Schedule upon the streets or portions of streets specified herein:

Asbury Avenue - City limits to Green Bay Road	30 mph
Burnham Place - Forest Avenue to Sheridan Road	30 mph
Central Street - Crawford Avenue to McDaniel Avenue	30 mph
Chicago Avenue - Howard Street to Dempster Street	30 mph
Church Street - City limits to Ridge Avenue	30 mph
Crawford Avenue - City limits south to City limits north	30 mph

Dempster Street - City limits to Elmwood Avenue	30 mph
Dodge Avenue - City limits to Simpson Street	30 mph
Elgin Road/Simpson Street (Golf Road) - City limits to McCormick Boulevard	35 mph
Emerson Street - City limits to Green Bay Road	30 mph
Green Bay Road - City limits to Emerson	30 mph
Howard Street - City limits west to City limits east	30 mph
Main Street - City limits to Ridge Avenue	30 mph
McCormick Boulevard - Emerson Street to Green Bay Road	35 mph
Oakton Street - City limits to Callan Avenue	30 mph
Ridge Avenue - City limits south to City limits north	30 mph
Sheridan Road - City limits south to City limits north	30 mph

SECTION 3: That the Evanston City Code, 1979, as amended, be and hereby is further amended by amending Schedule II, Section 10-11-2, to read as follows:

10-11-2: SCHEDULE II; SPEED LIMIT DECREASED: In accordance with subsection 10-1-7(C) of this Title and when signs are erected giving notice thereof, the maximum speed limit shall be as set forth in this Schedule upon the streets or portions of streets specified herein:

<u>Name of Street</u>	<u>Maximum Speed Limit</u>
Ashland Avenue - Crain Street to Wilder Street	20 mph
Colfax Street - Ridge Avenue to Sheridan Road	20 mph
Dempster Street - Forest Avenue to Lake Shore Boulevard	20 mph
Greenleaf Street - Pitner Avenue to Hartrey Avenue	20 mph

Harrison Street – McDaniel Avenue to Lincolnwood Drive	20 mph
Hartrey Avenue – Greenleaf Street to Dempster Street	20 mph
Hillside Lane – Entire length	20 mph
Lake Shore Boulevard – Dempster Street to Lee Street	20 mph
Madison Street – Ridge Avenue to Asbury Avenue	20 mph
Martha Lane – Entire length	20 mph
Monroe Street – Asbury Avenue to Ridge Avenue	20 mph
Pitner Avenue, east portion – Lee Street to Greenleaf Street	20 mph

SECTION 4: That ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 5: That this ordinance shall be in full force and effect from and after its passage, approval and publication in the manner provided by law.
