AN ORDINANCE

Amending Section 10-11-9, Schedule IX
Of the Evanston City Code, 1979

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EVANSTON, COOK
COUNTY, ILLINOIS:

SECTION 1: That the Evanston City Code, 1979, as amended, be and hereby is
further amended by deleting Section 10-11-9, Schedule IX(U) in its entirety and substituting in
lieu thereof the following new Section 10-11-9, Schedule IX(U):

(U) 2:00 A.M. to 6:00 A.M. daily – No Exceptions:

Pitner Avenue (Ord. 45-O-93)	Both Sides	Cleveland Street to dead-end

SECTION 2: That the Evanston City Code, 1979, as amended, be and hereby is further amended by adding to Section 10-11-9, Schedule IX the following new Section (MM):

(MM) Two o'clock (2:00) A.M. to five o'clock (5:00) A.M. daily, no exceptions:
