AN ORDINANCE

Vacating the East-West Legs of the Sherman Plaza Alley Between Benson Avenue and Sherman Avenue

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EVANSTON, COOK COUNTY, ILLINOIS:

SECTION 1: That the East-West Legs of the Sherman Plaza alley between Benson Avenue and Sherman Avenue:

PART OF THE SOUTHWEST QUARTER OF SECTION 18, TOWNSHIP 41 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

MORE PARTICULARLY DESCRIBED AS FOLLOWS:

PARCEL 1

THE REMAINING SOUTH 14 FEET OF THE FORMER TWENTY-FOUR (24) FOOT WIDE EAST-WEST ALLEY LYING NORTH OF AND ADJOINING LOTS 19 THROUGH 32, BOTH INCLUSIVE, IN BENSON'S SUBDIVISION OF BLOCK 65 IN THE VILLAGE OF EVANSTON, BEING A SUBDIVISION IN THE SOUTHWEST ½ OF SECTION 18, TOWNSHIP 41 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

PARCEL 2

THE REMAINING NORTH 14 FEET OF THE FORMER TWENTY-FOUR (24) FOOT WIDE EAST-WEST ALLEY LYING SOUTH OF AND ADJOINING LOTS 6 THROUGH 8, BOTH INCLUSIVE, IN BENSON'S SUBDIVISION OF BLOCK 65 IN THE VILLAGE OF EVANSTON AND LOT 3 IN THE RESUBDIVISION OF LOTS 1 TO 5 OF BLOCK 65 IN THE VILLAGE OF EVANSTON, LYING EAST OF THE WEST LINE OF SAID LOT 8 EXTENDED SOUTH, BOTH BEING SUBDIVISIONS IN THE SOUTHWEST ¼ OF SECTION 18, TOWNSHIP 41 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.


