

AN ORDINANCE

Amending Section 10-11-7, Schedule VII, and Section 10-11-12, Schedule XII
Of the Evanston City Code, 1979

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EVANSTON, COOK
COUNTY, ILLINOIS:

SECTION 1: That the Evanston City Code, 1979, as amended, be and hereby is
further amended by adding to Section 10-11-7, Schedule VII, (A) Passenger Loading Zones, the
following:

Maple Avenue Entrance to Hilton Gardens Inn

SECTION 2: That the Evanston City Code, 1979, as amended, be and hereby is
further amended by adding to Section 10-11-7, Schedule VII (D), Taxicab Stands or Zones, the
following:

University Place South side from Maple Avenue to Oak Avenue

SECTION 3: That the Evanston City Code, 1979, as amended, be and hereby is
further amended by deleting from Section 10-11-12, Schedule XII, PARKING METER ZONES,
Section (A) Two (2) hour maximum parking limit at rate of fifty cents (\$0.50) per hour, between
the hours of eight o'clock (8:00) A.M. and nine o'clock (9:00) P.M., the following:

<u>Street Name</u>	<u>Side of Street</u>	<u>Block/Blocks</u>
Maple Avenue	East	Church St. to Clark St.

SECTION 4: That the Evanston City Code, 1979, as amended, be and hereby is further amended by adding to Section 10-11-12, Schedule XII, PARKING METER ZONES, Section (A) Two (2) hour maximum parking limit at rate of Fifty cents (\$0.50) per hour, between the hours of eight o'clock (8:00) A.M. and nine o'clock (9:00) P.M., the following:

(A)	<u>Street Name</u>	<u>Side of Street</u>	<u>Block/Blocks</u>
	Maple Avenue	Both	Church St. to University Pl.

SECTION 5: That the Evanston City Code, 1979, as amended, be and hereby is further amended by adding to Section 10-11-12, Schedule XII, PARKING METER ZONES, Section (B) Two (2) hour maximum parking limit at rate of Fifty cents (\$0.50) per hour; between the hours of nine o'clock (9:00) A.M. and six o'clock (6:00) P.M., the following:

<u>Street Name</u>	<u>Side of Street</u>	<u>Block/Blocks</u>
Maple Ave.	Both	University Pl. to Emerson St.
Oak Ave.	Both	University Pl. to Emerson St.

SECTION 6: That the Evanston City Code, 1979, as amended, be and hereby is further amended by adding to Section 10-11-12, Schedule XII, PARKING METER ZONES, the following Section:

(I) Thirty (30) minutes at ten cents (\$0.10) per ten (10) minutes, between eight o'clock (8:00) A.M. and nine o'clock (9:00) P.M.:

<u>Street Name</u>	<u>Side of Street</u>	<u>Block/Blocks</u>
Maple Ave.	West	Church St. to Clark St.

SECTION 7: That all ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 8: That this ordinance shall be in full force and effect from and after its passage, approval, and publication in the manner provided by law.
