**AN ORDINANCE**

**Dedicating for Alley Purposes Certain Land  
Owned by Simon and Janette Thompson  
South of Simpson Street and East of Sherman Avenue**

**WHEREAS**, it is in the best interests of the City of Evanston to pave the east alley of the 2000 block of Sherman Avenue; and

**WHEREAS**, certain land, owned by Simon and Janette Thompson is needed for the aforesaid paving; and

**WHEREAS**, Simon and Janette Thompson are willing to dedicate to the City at no cost the portion of land they own; and

**WHEREAS**, it is in the best interests of the City to accept the dedication from Simon and Janette Thompson,

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF  
THE CITY OF EVANSTON, COOK COUNTY, ILLINOIS:**

**SECTION 1:** That the portion of property, 10.0 feet in width and 40.0 feet in length, south of Simpson Street and east of Sherman Avenue, legally described as follows:

THE WEST 10 FEET OF THE NORTH 40.0 FEET OF LOT 4 IN BLOCK 4  
IN THE VILLAGE (NOW CITY) OF EVANSTON IN SECTION 18,  
TOWNSHIP 41 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL  
MERIDIAN, IN COOK COUNTY, ILLINOIS,

PIN 11-18-105-027 (part of)  
Part of 2024 Orrington Avenue

as set forth in a Plat of Dedication dated February 5, 2004, by Simon and Janette Thompson, attached to and incorporated into this Ordinance, be and hereby is accepted as, and dedicated for, a public alley by the City Council of the City of Evanston.

**SECTION 2:** That a certified copy of this Ordinance, together with a true and correct plat of said dedication, be recorded at the Office of Recorder of Deeds in Cook County, Illinois.

**SECTION 3:** That all ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SECTION 4:** That this Ordinance shall be in full force and effect from and after its passage, approval, and publication in the manner provided by law.

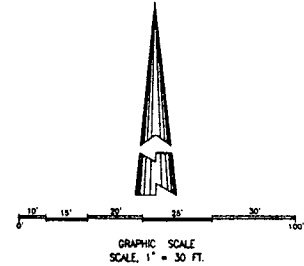
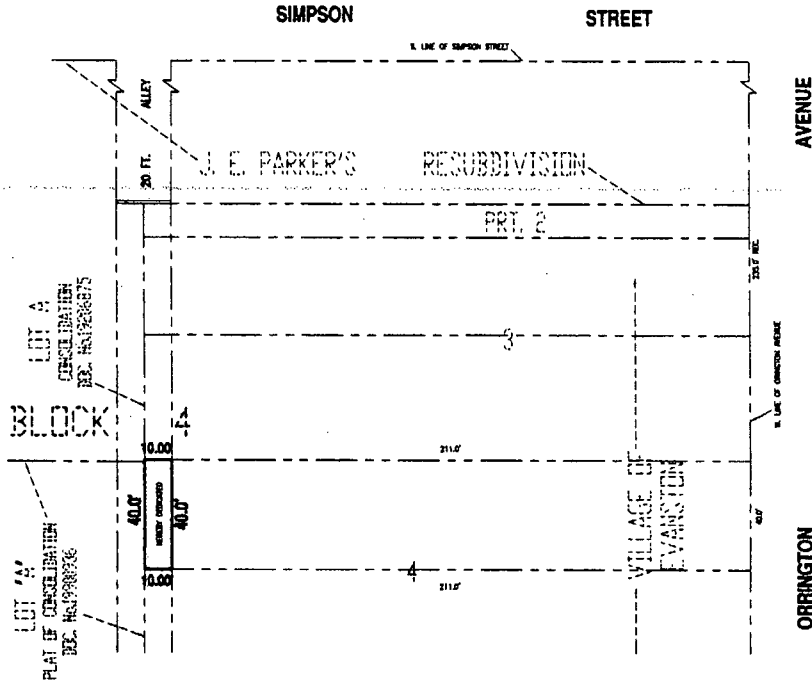
