AN ORDINANCE


Transferring the Jurisdiction of Ridge Avenue from Thirty-Three Feet North of Lyons Street Southerly to the Centerline of Howard Street (South Corporate Limits) in its Entirety from the Illinois Department of Transportation to the City of Evanston

WHEREAS, upon the transfer of jurisdiction of Ridge Avenue from thirty-three feet (33') north of Lyons Street southerly to the centerline of Howard Street (south corporate limits) in its entirety from the Illinois Department of Transportation ("IDOT") to the City of Evanston, the City of Evanston will be required to assume the maintenance of said jurisdiction; and

WHEREAS, it is in the best interests of the City of Evanston to assume said jurisdiction and maintenance;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF EVANSTON, COOK COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The City Manager is authorized to sign the jurisdictional transfer agreement regarding Ridge Avenue from thirty-three feet (33') north of Lyons Street southerly to the centerline of Howard Street (south corporate limits), attached to this ordinance as Exhibit A and incorporated herein, and the City Clerk is hereby directed to forward a certified copy of this Ordinance to the State of Illinois through its District Engineer's Office at 201 West Center Court, Schaumburg, Illinois.



SECTION 2: That all ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 3: That this Ordinance shall be in full force and effect immediately upon its passage in the manner provided by law.








LOCATION MAP
