AN ORDINANCE

Amending Ordinance 46-0-99 Pertaining to Fees for Fire Prevention Measures

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EVANSTON, COOK COUNTY, ILLINOIS:

SECTION 1: That Section III(C) of Ordinance 46-0-99 is hereby amended to read as follows:

III. ELECTRICAL PERMIT FEES:

C. The fees for electrical interior communication systems and burglar alarms shall be as follows:

Low voltage communication systems and low voltage burglar alarms

SECTION 2: That Section VIII of Ordinance 46-0-99 is hereby amended to read as follows:

VIII. FIRE LIFE SAFETY SYSTEMS REVIEW AND PERMIT FEES:

A. The permit and plan review fees for automatic sprinkler systems with stand pipes designed in accordance with NFPA 13 and 13R shall be as follows:

NUMBER OF SPRINKLERS	FEE
1 to 20	\$200.00
21 to 100	\$420.00
101 to 200	\$560.00
201 to 300	\$645.00
301 to 500	\$950.00
Over 500	\$950.00 plus \$1.06 for each sprinkler over 500

B. The permit and plan review fees for residential automatic sprinkler systems designed in accordance with NFPA 13D shall be as follows:

NUMBER OF SPRINKLERS	FEE
1 to 25	\$180.00
26 to 50	\$215.00
51 to 100	\$225.00
Over 100	\$225.00 plus \$1.12 for each sprinkler over 100

- C. The permit and plan review fees for systems consisting of only standpipes shall be two-hundred and fifteen dollars (\$215.00) per standpipe.
- D. The permit and plan review fees for fire pumps shall be one-hundred and ninety-five dollars (\$195.00) per fire pump.
- E. The permit and plan review fees for fire detection and alarm systems shall be as follows:

NUMBER OF ALARM DEVICES	FEE
1 to 10	\$195.00
11 to 25	\$280.00
26 to 50	\$420.00
51 to 75	\$680.00
76 to 100	\$825.00
101 to 125	\$990.00
Over 125	\$990.00 plus \$5.52 per additional device over 125

- F. The permit fees and plan review fees for restaurant wet chemical systems shall be two-hundred and eighty dollars (\$280.00) per system.
- 1. For each additional restaurant wet chemical system reviewed at the same time and in the same building, the permit and plan review fees shall be one-hundred and ten dollars (\$110.00) for each such additional system.
- 2. For purposes of subsection (F)(1), a restaurant wet chemical system will not be counted as an additional restaurant wet chemical system based on the existence of multiple hoods where all such hoods are connected to the same wet chemical system for which the two-hundred and eighty dollar (\$280.00) permit and plan review fee will be paid.

G. The permit and plan review fees for gas suppression systems or dry chemical systems shall be as follows:

101 to 200	\$320.00
201 to 300	\$335.00
301 to 400	\$365.00
401 to 500	\$390.00

Over 1,000	\$560.00 plus \$.28 for each pound of Agent over 1,000

SECTION 3: That all ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 4: That this Ordinance shall be in full force and effect from and after its passage, approval, and publication in the manner provided by law.
