AN ORDINANCE

Transferring Jurisdiction of Certain Sections of Sheridan Road and Isabella Street from the Illinois Department of Transportation to the City of Evanston

WHEREAS, on August 13, 2001, the City executed an Intergovernmental Agreement with the Village of Wilmette for the reconstruction of Sheridan Road and Isabella Street for the limits stated below. The Village of Wilmette is the lead agency in completing design and construction. Phase I and Phase II engineering is now complete; and

WHEREAS, upon adoption of this Ordinance, the City of Evanston will enter into a Local Agency State Agreement for Jurisdictional Transfer with the Illinois Department of Transportation ("IDOT") for the purpose of roadway improvement of certain sections of Sheridan Road and Isabella Street, Section No. 01-00228-00-FP, a copy of which is attached hereto and incorporated herein by reference as Exhibit A.

WHEREAS, upon the completion of the roadway improvement and after final inspection by IDOT, the City of Evanston is required to assume jurisdiction and maintenance for Sheridan Road from Isabella Street to the north City limit at Wilmette, and Isabella Street from Bryant Avenue to the Ridge/Sheridan intersection (hereinafter, "the Improvement Area") as described by Addendum 1 attached hereto and incorporated herein by reference; and

WHEREAS, it is in the best interests of the City of Evanston to assume said jurisdiction of the Improvement Area;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF EVANSTON, COOK COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: That upon the completion of the roadway improvement of Section No. 01-00228-00-FP, and upon final inspection by IDOT, the City of Evanston shall assume jurisdiction and maintenance of the Improvement Area.

SECTION 2: That the roadway within the aforescribed Improvement Area shall be added to the Municipal Street System after final inspection by IDOT.

SECTION 3: The City Manager is authorized to sign the Local Agency State Agreement for Jurisdictional Transfer for Section No. 01-00228-00-FP, and the City Clerk is hereby directed to forward a certified copy of this Ordinance to the State of Illinois through its Deputy Director of Highways, Diane M. O'Keefe, P.E., at the Division of Highways, Region One, District One, 201 West Center Court, Schaumburg, Illinois 60196-1096.


SECTION 4: That all ordinances or parts of ordinances in conflict herewith are hereby repealed.

WHEREAS, the authority to enter into this contract is granted the STATE by Section 4-409 of the Illinois Highway Code and the authority to make changes in the State Highway System is granted the State under Section 2-101 of the Illinois Highway Code.

WHEREAS, the authority to make changes to the Municipal Street System is granted to the Municipality by Section 7-101 of the Illinois Highway Code

NOW THEREFORE IT IS AGREED that the corporate authority of said municipality will pass an ordinance providing for the transfer of the above location and shall attach hereto and make a part hereof a copy of a location map as Addendum No. 1 and a copy of the ordinance as Addendum No. 2, and

Include for Counties Only

WHEREAS, the authority to make changes to the County Highway System is granted to the County by Section 5-105 of the Illinois Highway Code.

NOW THEREFORE IT IS AGREED that the County Board of said County will pass a resolution providing for the transfer of the above location and shall attach hereto and make a part hereof a copy of a location map as Addendum No. 1 and a copy of the resolution as Addendum No. 2, and

Include for Township/Road Districts Only

WHEREAS, the authority to make changes to the Township/Road District System is granted to the Highway Commissioner under Section 6-201.3 of the Illinois Highway Code and said Highway Commissioner shall attach hereto and make a part hereof a copy of a location map as Addendum No. 1, and

IT IS MUTUALLY AGREED, that this jurisdictional transfer will become effective 21 calendar days after (check one)

 Approval of Land Conveyance

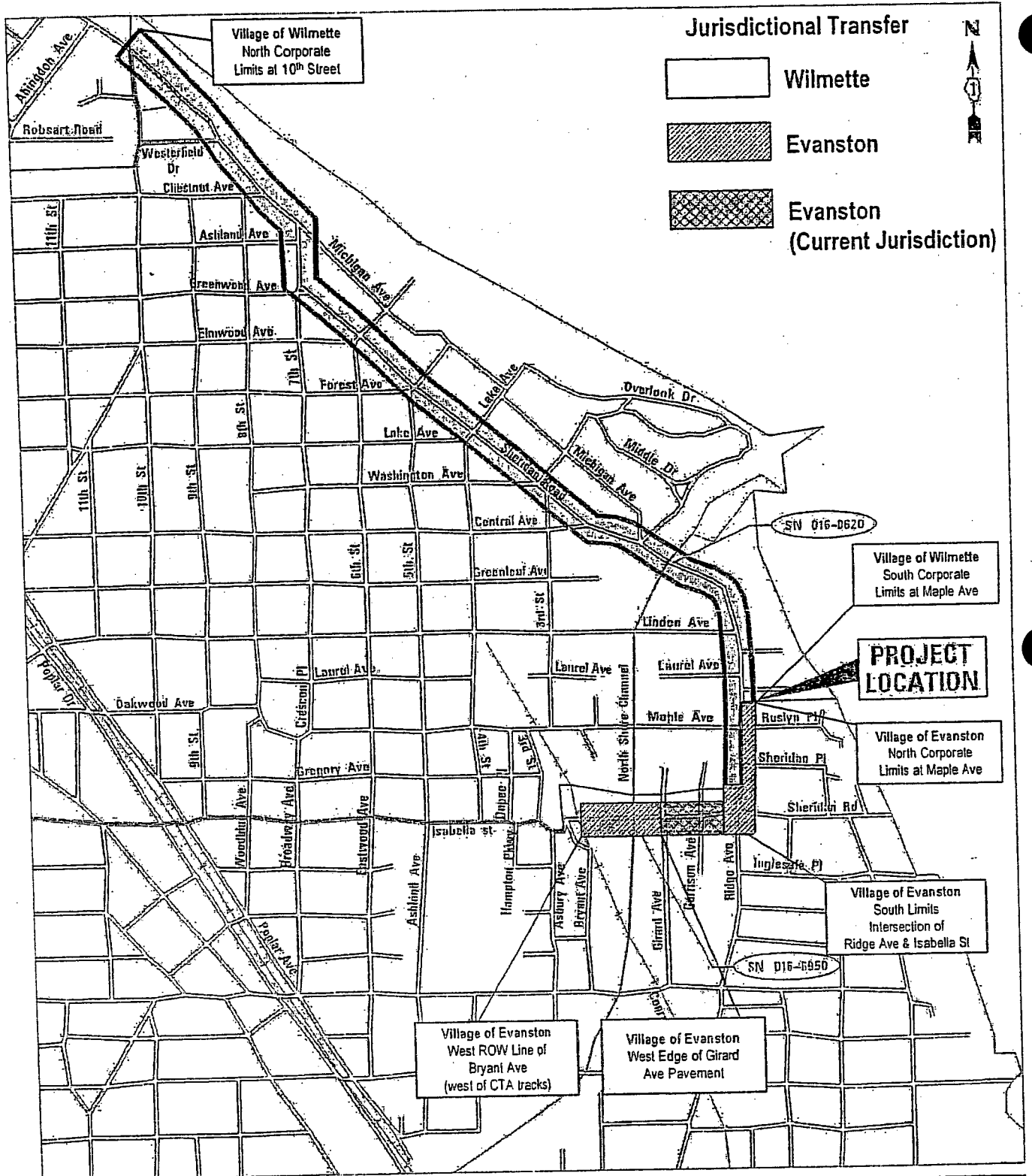
