AN ORDINANCE

**Amending Various Sections of Title 10, Chapter 11 of the
Evanston City Code, "Traffic Schedules"**

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL
OF THE CITY OF EVANSTON, COOK COUNTY, ILLINOIS:

SECTION 1: That Title 10, Chapter 11 of the Evanston City Code
of 1979, as amended, is hereby further amended by revising Subsection 10-11-
12(A) to read as follows:

(A) Two (2) hour maximum parking limit at rate of seventy-five cents (\$0.75) per
hour, between the hours of eight o'clock (8:00) A.M. to nine o'clock (9:00) P.M.:

SECTION 2: That Title 10, Chapter 11 of the Evanston City Code of 1979, as amended, is hereby further amended by revising Subsection 10-11-12(B) to read as follows:

(B) Two (2) hour maximum parking limit at rate of seventy-five cents (\$0.75) per hour, between the hours of nine o'clock (9:00) A.M. to six o'clock (6:00) P.M.:


SECTION 3: That all ordinances or parts of ordinances in conflict herewith are hereby repealed.


SECTION 4: That if any provision of this Ordinance 27-O-08 or application thereof to any person or circumstance is held unconstitutional or otherwise invalid, such invalidity shall not affect other provisions or applications of this Ordinance 27-O-08 that can be given effect without the invalid application or provision, and each invalid provision or invalid application of this Ordinance is severable.
