### **AN ORDINANCE**

# Dedicating a Portion of 1228 Emerson Street to the City of Evanston

WHEREAS, Ferris Homes, Inc., has requested dedicating a portion of 1228 Emerson Street to the City of Evanston, Illinois, part of Permanent Index Numbers 11-18-111-013 and 11-18-111-015; and

WHEREAS, this portion of 1228 Emerson Street is located east of and adjacent to a public alley located south of Emerson Street, and west of Green Bay Road; and

WHEREAS, Ferris Homes, Inc., has entered into a contract to purchase 1228 Emerson Street, a portion of which lies east of the public alley; and

WHEREAS, Ferris Homes, Inc., desires to construct a forty-nine (49) unit condominium development and provide safe vehicular access between the development and said public alley by dedicating this portion of 1228 Emerson Street to the City;

WHEREAS, Ferris Homes, Inc., will construct improvements to the public alley as required of the approved Planned Unit Development granted by Ordinance 10-O-05; and

WHEREAS, it is in the best interests of the City to accept the dedication from Ferris Homes. Inc.,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EVANSTON, COOK COUNTY, ILLINOIS:

SECTION 1: That the certain portion of 1228 Emerson Street legally described as:

THAT PART OF LOT 1 AND LOT 2 (EXCEPT FROM SAID LOT 1 THE FOLLOWING TRACT: BEGINNING AT THE NORTHEASTERLY CORNER OF LOT 1 AND RUNNING SOUTHEASTERLY 120 FEET PARALLEL TO AND ALONG THE WESTERLY LINE OF THE PUBLIC WAY FORMERLY KNOWN AS WEST RAILROAD AVENUE AND NOW KNOWN AS GREENBAY ROAD: THENCE WESTERLY 60 FEET PARALLEL TO THE NORTH LINE OF SAID LOT 1: THENCE NORTHWESTERLY PARALLEL TO THE WESTERLY LINE OF SAID RAILROAD AVENUE OR GREENBAY ROAD, 120.00 FEET: THENCE EASTERLY 60.00 FEET TO THE PLACE OF BEGINNING), ALL IN CIRCUIT COURT PARTITION OF LOTS 23 AND 25 IN COUNTY CLERK'S DIVISION OF UNSUBDIVIDED LANDS IN THE NORTHWEST QUARTER OF SECTION 18, TOWNSHIP 41 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, (EXCEPT THE PORTION TAKEN OR USED FOR GREENBAY ROAD NOW KNOWN AS RIDGE AVENUE), IN COOK COUNTY, ILLINOIS,

### **DESCRIBED AS FOLLOWS:**

BEGINNING AT THE NORTHWEST CORNER OF SAID LOT 1; THENCE EAST ALONG THE NORTH LINE OF SAID LOT 1, NORTH 90 DEGREES 00 MINUTES 00 SECONDS EAST, 29.01 FEET; THENCE SOUTH 29 DEGREES 39 MINUTES 38 SECONDS WEST, 28.79 FEET; THENCE SOUTH 05 DEGREES 00 MINUTES 00 SECONDS WEST, 30.68 FEET; THENCE SOUTH 03 DEGREES 55 MINUTES 56 SECONDS EAST, 99.55 FEET; THENCE SOUTH 16 DEGREES 04 MINUTES 04 SECONDS WEST, 24.12 FEET TO A POINT ON THE WEST LINE OF SAID LOT 2; THENCE NORTHERLY ALONG WEST LINE OF LOTS 1 AND 2, NORTH 03 DEGREES 55 MINUTES 56 SECONDS WEST, 178.49 FEET TO THE PONT OF BEGINNING, ALL IN COOK COUNTY, ILLINOIS,

and depicted in the attached Plat of Dedication incorporated into this Ordinance as Exhibit A, is hereby dedicated, inasmuch as the corporate authorities of the City of Evanston have determined that the public interest will be served by the aforesaid dedication, provided that said dedication shall be subject to the following terms and conditions:

1. That in the event of litigation, Ferris Homes, Inc., will hold the City of Evanston harmless and defend it against any lawsuits resulting from the subject dedication.

**SECTION 2**: That a certified copy of this Ordinance 82-O-08, together with a true and correct plat of said dedication, be recorded at the Office of Recorder of Deeds in

Cook County, Illinois.

**SECTION 3:** That all ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SECTION 4:** That this Ordinance 82-O-08 shall be in full force and effect from and after its passage, approval, and publication in the manner provided by law.


