AN ORDINANCE

Amending the Evanston City Code,
Title 10, "Motor Vehicles and Traffic,"
Chapter 11, "Traffic Schedules,"
Section 12 (H), "Schedule XII; Parking Meter Zones"

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EVANSTON, ILLINOIS, COOK COUNTY, ILLINOIS:

SECTION 1: That Title 10, Chapter 11 of the Evanston City Code of 1979, as amended, is hereby further amended in Section 12, "Schedule XII; Parking Meter Zones," Subsection (H) to read as follows:

(H) The following city owned and operated parking lots are hereby declared to be parking meter zones for the maximum parking time limits, daily hours, and amounts hereinafter stated:

SECTION 2: That all ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 3: That if any provision of this Ordinance 56-O-09 or application thereof to any person or circumstance is held unconstitutional or otherwise invalid, such invalidity shall not affect other provisions or applications of this Ordinance that can be given effect without the invalid application or provision, and each invalid application of this Ordinance is severable.

SECTION 4: That this Ordinance 56-O-09 shall be in full force and effect from and after its passage, approval, and publication in the manner provided by law.
