AN ORDINANCE

**Proposed Budget and Appropriation Ordinance
For Town Purposes, For First Half of Fiscal Year Ending
September 30, 2011**

WHEREAS, a tentative Budget and Appropriations Ordinance for the Town of the City of Evanston, Cook County, Illinois, was prepared and filed in the Office of the Town Clerk; and

WHEREAS, a public hearing was held on the Budget and Appropriation Ordinance on June 13, 2011;

WHEREAS, all persons desiring to be heard on the matter of the budget were heard, and the Budget was submitted to the Township Board of the Town of Evanston, Cook County, Illinois;

WHEREAS, the Human Services Committee sitting as certain members of the Township Board of the Town of Evanston considered the proposed budget at open meetings in May and June 2011;

WHEREAS, the Township's fiscal year begins April 1, 2011 and ends March 31, 2012, and thus the first quarter of the fiscal year will elapse as of June 30, 2011;

WHEREAS, the Township Board has previously met, considered, and already approved certain of the Township bills incurred during the first quarter of this fiscal year;

WHEREAS, the Township Board of the Town of Evanston further deliberated regarding the proposed budget on June 27, 2011, and in the Township Board's dialog with the Township Attorney and the City Manager, discussion was had regarding approving the Township budget for 90 days, incepting July 1, 2011 and continuing through September 30, 2011;

WHEREAS, pursuant to 60 ILCS 1/80-60, the Township Board may adopt all or part of the tentative budget and appropriation ordinance, as the Township Board deems necessary;

WHEREAS, pursuant to 60 ILCS 1/85-13, the Township Board may expend funds to provide certain services to the residents of Evanston Township;

WHEREAS, at the June 27, 2011 meeting, the Township Board approved the budget for the Township for the first half of the Township's fiscal year, through September 30, 2011; and

WHEREAS, the Township Board shall reconvene at a Special Township Meeting on September 19, 2011, to consider the budget and appropriations for the Town of Evanston for the second half of the fiscal year, October 1, 2011 through March 31, 2012.

BE IT ORDAINED BY THE TOWNSHIP BOARD OF THE TOWN OF THE CITY OF EVANSTON, COOK COUNTY, ILLINOIS:

SECTION 1: That the following Budget for the first half of the fiscal year commencing April 1, 2011 and ending September 30, 2011 (6 months), be and is hereby approved and adopted.

SECTION 2: That there is hereby appropriated for use of this Town for first half (6 months) of said fiscal year, the following:

FROM THE TOWN FUND, A TOTAL OF	\$137,876.50
FROM THE GENERAL ASSISTANCE FUND A TOTAL OF	<u>\$492,276.50</u>
TOTAL APPROPRIATIONS	\$631,153.00

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 4: This Ordinance shall be in full force and effect from and after its passage, approval, and publication in the manner provided by law.
