AN ORDINANCE

Amending City Code Section 6-15-14-7 "Active Ground Floor Uses"

NOW BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EVANSTON, COOK COUNTY, ILLINOIS, THAT:

SECTION 1: City Code Section 6-15-14-7, "Active Ground Floor Uses," of the Evanston City Code of 2012, as amended, is hereby further amended to read as follows:

6-15-14-7. - ACTIVE GROUND FLOOR USES.

In Subareas 3, 4, 5, 6 and 7, active uses shall occupy the ground floor level along the primary street frontage. "Active uses" are hereby defined in the table below along with the matter in which they are allowed in each subarea as either permitted use ("P") or special use ("S").
