AN ORDINANCE

Amending City Code Section 10-8-3 to Revise Wheel Tax Late Fees NOW BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EVANSTON, COOK COUNTY, ILLINOIS, THAT:

SECTION 1: Section 10-8-3 "Schedule of License Fees" of the Evanston

City Code of 2012, as amended ("City Code"), is hereby amended as follows:

10-8-3. - SCHEDULE OF LICENSE FEES.

(D) Fee Increases. The annual license fee for all motor vehicles, antique motor vehicles, automobile dealer plates, buses, recreational vehicles, motorcycles, taxicabs or livery cabs, trailers, motor trucks and tractor trailers shall be increased in accordance with the following schedule when obtained after September 30 of the license calendar year by persons whose motor vehicles were registered or required to be registered in Evanston on or before September 30 of said year. Said fee is to be in addition to the fee set forth in Subsection (A) of this Section:
