My family is opposed to the use of the Margarita Inn for housing the homeless. In the past year, there have been many times when the homeless just stand around smoking on the sidewalk and it's difficult to get around them.

Also turning Evanston into a homeless shelter is chasing people out of Evanston. It certainly has chased businesses out of Evanston. With fewer businesses in each of the four 'downtown areas' there is little reason to walk around.

Dear Mayor Bliss, City Council Members, and Melissa Klotz, Zoning Administrator,

We, members of the Lutheran Campus Ministry at Northwestern University, attended the November 2022 LUC meeting where the special use permit was approved for Margarita Inn, and we are asking you to continue to support our neighbors in Evanston who would be homeless without the Margarita Inn and to support the ongoing work of Connections for the Homeless at Margarita Inn.

Our campus ministry has had a relationship with Connections for the Homeless for over 20 years. We have worked with Connections for the Homeless (particularly through Hilda's Place transitional shelter, the Bridges to Home program, and the Margarita Inn) supporting their mission and efforts with financial donations, monthly suppers, bag lunches, clothing drives, and our volunteer time. Before the pandemic, we had first-hand experience of serving dinner and sitting down to eat with the residents at the Connections' transitional shelter where we heard the residents speak of their daily lives -looking for jobs, going to jobs, searching for an apartment, preparing to move to their own apartment, the challenges of health and medical needs, navigating paperwork and the "system," and, then, of course, we also got to hear the stories of their families, their life experiences beyond being homeless, their goals and hopes. We've heard their stories and challenges directly from them, and we've also heard the concrete differences that Connections for the Homeless was making in their lives. During the pandemic, we saw how quickly Evanston could house and feed homeless people if we wanted to, and Connections for the Homeless was the agency who effectively implemented shelter. We have witnessed the difference that Connections for the Homeless and their Housing First principles have made with the use of the Margarita Inn, and we support its ongoing purpose as a shelter that can lead to stable housing which leads to a higher quality of life and more stability in our community.

As a faith community, we believe that we are to love and serve our neighbors and to care for the most vulnerable in our midst. We continue to provide bag lunches and monthly meals to the Margarita Inn residents, and, even though we miss interacting with the residents, we are grateful that they now have shelter that includes their own space in which they are eating these meals. We are grateful that we can support our neighbors as they seek to live on their own, and we know they have to be happier having their own space and place to call home.

Our ministry is in a historic and upper-class housing district in Evanston, and we occasionally have people who are homeless show up at our ministry asking for support. We do not provide cash support nor are we equipped to provide the support they need. However, we do direct them to Connections, and then we support the work of Connections as much as we are able as a student ministry because we believe in helping the homeless, and we believe the mission of Connections for the Homeless accomplishes this life-giving work.

RE: Zoning Petition 22ZMJV-0078; Connections for the Homeless, 1566 Oak Avenue

Evanston Land Use Commission:

This matter involves a petition for special use approval by Connections for the Homeless for the operation of a rooming house for temporary housing for homeless individuals at the Margarita Inn, 1566 Oak Ave., Evanston, IL. ("Subject Property") We are legal counsel to BCH1555, LLC, the owner of the property at 1555 Oak Ave. across the street from the Subject Property. 1555 Oak Avenue is within a five-hundred-foot (500') radius of the Subject Property, and BCH1555 LLC wishes to object to the special use under consideration.

Pursuant to Section 6-3-5-17 of the Evanston City Code, we hereby submit this written request for a continuance of the public hearing in this matter for the purpose of presenting evidence to rebut the testimony given by the applicant.

Section 6-3-5-17 of the Evanston City Code provides:

- (A) Applicants for a special use (exclusive of planned developments) and owners of property within a five hundred (500) foot radius of the subject property, inclusive of public roads, streets, alleys and other public ways, shall have the following rights, in addition to any others they may possess by law, at any special use hearing before the Zoning Board of Appeals:
 - 1. To inspect all documents and material submitted as part of the application for the special use prior to the hearing.
 - 2. To reasonably examine all witnesses testifying.
 - 3. To present witnesses on their behalf.
- (B) Eligible property owners, as set forth above, who wish to object shall, upon written request, be granted one (1) continuance for the purpose of presenting evidence to rebut testimony given by the applicant. The date of such continued hearing shall be at the discretion of the board.
